Writing to register disapproval regarding the behavior and discipline in the court of

As the defendant in a case that was originally filed as felony aggravated assault, for which I had various property stored in the jail and in another facility, including my only pair of glasses (I am almost half legally blind), I spent days in jail and upon release after the charge was reduced to misdemeanor aggravated assault, my only pair of glasses was not returned to me with my other property, nor was I allowed to check my belongings before being released. The charge was again later filed as misdemeanor minor assault.

I cannot afford to pay utility bills or purchase another pair of glasses and have no more cleanable contact lenses.

I have not been able to work regularly since being stabbed in the chest in my own home at the above address on March 23, 2008, and had an injunction against harassment filed against the assailant (State vs \_\_\_\_\_), who, despite repeatedly telling officers that she was sorry for not having killed me, was given 200 days, her family of murderers child custody, and me no realistically efficacious rights whatsoever...and she has not made one of her court-ordered restitution payments in a timely fashion.

So I made motion to Chief Magistrate \_\_\_\_\_ that my property be returned, and this motion was denied because he wrote that the property had already been released, however those at the property detention facility - which I have no vehicle to drive to and pick up property - stated they needed a written note to return property, which neither the police nor judge will effectively render.

When I showed up in court, I requested representation. Judge \_\_\_\_\_ raised his voice to ask me if I was seeing a doctor for mental problems. After stating I was not, another attorney came into the courtroom, and without identifying himself as another prosecutor, (I thought he was a defense attorney) not only tried to talk me out of my right to plead innocent as is obviously his unconstitutional habit, but again, with his wicked, obese, aggressive and carnivorous frame, shouted before the court to ask if I had mental problems.

Given that a child I had never met, who in fact assaulted me in a public park after I played my guitar alone to a lake of ducks, was directed to harass me by someone I had never met, who was apparently taking care of an autistic child, and that the child, despite my loud and clear verbal warning, assaulted me, dangerously within a foot or two of a lake, I made written suggestion to the judge that Child Protective Services be contacted.

The egregious male prosecuting attorney postponed the date that I might have given this information to the judge, wrote a long tome regarding lack of employees and fiscal cutbacks, and in doing so neither the interests of the alleged victim, justice, nor the courts have been served, and more time has been wasted, and an endangered child, endangered by effeminate bad guidance and reckless direction, has failed to be taken care of because of the inexhaustible hubris of the courts.

Gentlemen, I have completed three full college and university degrees, with honors, after graduating valedictorian from \_\_\_\_\_ School in only three years and actually commanded all earth by fax, regular mail, poster and email to 5000 emails of international press, industry, religious and government officials in every nation, from 16 nations, in 10 languages. Some of those nations were at war, impoverished...Egypt, India, Pakistan...and although I have been arrested and detained in 7 nations, I have never been stabbed and mistreated more than by the \_\_\_\_\_ Courts, the despicable, carnivorous and proud police, and the endlessly dysfunctional courts, administrations, institutions and citizens of \_\_\_\_\_ and Arizona - and the wicked ruling class churches and representatives from hell that

control their bodies.

Ludicrous, effeminate, wicked, proud and sadistic phony humbugs of utterly bad and purely egoistic worse-than-nothing bad judgment.

I have filed three Civil Rights cases that have been approved by the Arizona Attorney General's Office (COMDA Calendars, CRD # \_\_\_\_\_ EEOC #: \_\_\_\_\_ ; Allstate Imaging, \_\_\_\_\_ and \_\_\_\_\_ Medical Center) in which I and other employees were sexually, racistly and in other ways harassed and controlled, and the behavior of the courts is not only grievously allowing the continued endangerment of victims and those victimized by "set ups" where in children are propelled into cars and adults to be sacrificed for whatever harm and reward the courts and the sadism of sexist, racist and religious prejudiced enforcement can bring, but the sexist wickeds of enforcement and the judiciary, and they are this utterly transparently, are wasting not only everyone's time and lives, but wasting funds and impeding those of intelligence from, even in pathetic reformist ways, remedying the situation.

I am writing to inspire \_\_\_\_\_ to discipline wicked white supremacists and carnivorous, sadistic, unconstitutional and illegal phony bastards of the courts and find effective justice for children misused to be made into idiots to justify female control...and I will not accept the female defense attorney. I am not old enough to play with girls that way.

This writer and person does not really write for anything as primitive as vengeance and social justification, as you may wrongly imagine...if the ignoble, uncompassionate and relentlessly uncorrected denouements of earth continue to violate and harass me, might even be forced to conclude that I should attempt to collect consulting fees.
