ORDER

The complainant alleged two judges failed to notify him of the dates and times of hearings because his ex-wife is a court employee and one judge teaches his children in Sunday School. The commission reviewed the complaint and the responses from the judges and found no evidence of ethical misconduct on the part of either judge. The complainant's ex-wife does not work for the court and neither judge has had a social or religious relationship with her. In addition, according to court records, the complainant was notified of both hearings. The complaint is dismissed pursuant to Rules 16(b) and 23.
