Community Property → Judge Hindered and Obstructed my ability to obtain a lawyer and have time to obtain evidence in my divorce case. On July 31st 2009 I had motioned Judge for temporary orders to ask for spousal support and to get half the money out of Husband checking acct (in husband) name alone) to obtain a lawyer. This hearing turned out to be a resolution hearing of which I had to present a hurried response. When I explained to Judge that I was under the assumption this hearing was about my requests for S.S. + money from bank. I had to beg the Judge for spousal support - I do not work - had no income and was desperate. At this hearing I represented myself. Finally the Judge gave me \$80000 for Aug + 400 for September. This was a 32 year marriage! I did not want this divorce. When I then begged the Judge for 1/2 the money in checking acct to get a lawyer. He told me do it yourself! This was a real slap in my face. I have a 89yr old mother I take care of. Now I was spending all my time in the Law Library. Needless to say Mom ended up in the hospital. That checking money was Community Property Money - He should of Gave me half so that I would have adequate representation. I knew from this hearing the Judge was not going to be fair. Boy was I Right!

My First motion for tempo Orders was ^{Filed} on 6/15/09 - Hearing AT that hearing he told me he me Instructions on how the trial were to be done. This minute entry of the hearing was not electronically filed till 8/25/09 at 8:00am. I did not receive anything regarding the trial exhibits till the end of Aug. Hindering me further in trying to collect evidence. The Judge Did not order any disclosure of Financial information of husband. I was unaware that I could of asked for this.

ON August 31, 2009 at 10:47AM I motioned For Judge to reset trial date of 9/15/09 So that I could Subpeona bank and other business for information on husband. Husband has been hiding money and bought land in brother / sister's names. I had proof. But I needed other proof. The Judge denied my motion on 9/2/09 - He was very quick in denying all my motions.

On Aug 28, 2009 I motioned the Judge to quash all correspondence to

because they were privately written under great duress. Mr. was using them against me. Of course the Judge denied this motion also.

I knew I was trying to fight a losing battle! There would be no justice for me! This Judge was flying this case at Super Sonic Speed thru trial.

At Trial I had so many exhibits (50) to be exact! Showing how my husband bought land in Siblings name. How he was hiding his payroll cts in another Bank account with sister

name and many many other things. The Judge would not consider any of it. He took my husband attorney side in everything. He (the Judge) even allowed a phone conversation in as evidence when it was explicitly stated NO evidence would be allowed in After 9/8/09. I was not even informed of this evidence before hand. I didn't even know I was being taped - Isn't that against the Law?

not contributed since I quit
the company. But the Judge
would of given him $\frac{1}{2}$ of my
IRA because I was honest!

I am Incable of making
the kind of income I've become
accustomed too. 32 years of
marriage should amount to more
than a \$1,000.00 a month! For
2 years! I'd like to see the
Judge try to live on that income!

I have congested heart failure
need daily doses of medication
I also have severe lower back
pain. This Judge showed
no compassion, mercy or justice!
