Judge on or about 11-5-09 after that hearing conducted by Judge on record stated he would discuss the County Attorney's objection to this hearing being conducted. He stated he would privately out of the hearing of defendant discuss what would be done. They privately in conspiracy arranged for unwanted counsel to not be present again. Knowing I had raised the issue of being held over 1 year on a class 6 felony that carries only 1 year without trial or preliminary hearing. Knowing this there arrangement with the Sheriff County Attorney and WAS to incite and provoke reaction from me by the arrangement of 11-12-09. The south western bell phone records can be subpoenaed to here all the conversation that went on between the Sheriff County Attorney, Judge and Judge to hear exactly what was said in this conspiracy intending my harm. On 11-13-09, both Judges and County Attorney and Sheriff selected Judge to preside, the Sheriff had arranged for 4 guards rather than the two that normally is sufficient with instructions to carry out this attack in conspiracy intending my harm or death. Knowing that after a 365 day illegal custody in which through various tactics I'd been kept out of court and imprisoned.

Did not appear intentionally after being informed by the BAR Association a complaint had been lodged against him. Now in hostility he was carrying his part intending through none appearance to provoke a reaction on top of 365 days of threat duress and coercion through torture and death threats. Judge in carrying out her part held my cause until last, the number that were called before me is record. It appeared they intended not to call my cause period. I informed the D.O. to inform the judge that I had motions I needed to submit, and did not intend to be kept out of court any longer. Arnold continued to intentionally disregard my intent to submit motions in open court, after already being informed and intentionally from this conspired arrangement over the private arrangement as aforesaid did not let me present my motions. Intentionally frustrated me, after calling my case isnerous what I had to say on record permitting unwanted counsel to talk so that I had no right to be heard without counsel and present motions. Then as instructed I was grabbed by 4 officers slammed head first into the wall in full restraints and thrown to the floor head first a stun gun was placed in my back while 4 officers held me to the ground. This incident resulted from the phone conversation between involving me the aforesaid with the intent as planned in frustration an incident so that I would be attacked, in retaliation intending to not release me.
