**ORDER**

The complainant alleged the judge made erroneous rulings and improperly allowed his children to be present in the courtroom during testimony involving sensitive issues. The commission reviewed the allegations, the recordings of the hearings, and the judge's response and found no evidence of ethical misconduct on the part of the judge. The complaint is dismissed pursuant to Rules 16(a) and 23.

1) At appearances in Judge \_\_\_\_\_ courtroom from January, 2010 until present, Judge \_\_\_\_\_ has allowed - and invited my little children, ages 10 and 11, to be present during court proceedings, while facts have been expounded about their mother's ( \_\_\_\_\_ ) diagnosis of Borderline Personality Disorder, (testified about + on record) it's symptoms, and the terrible consequences that this Disorder imposes on the children, if not - yet unable to be, by testimony of Dr. \_\_\_\_\_ PhD - controlled.

2) Judge \_\_\_\_\_ has nearly totally dismissed the testimony of Dr. \_\_\_\_\_ PhD + Psychologist \_\_\_\_\_ MEd, as not credible in evaluating the children's mother's mental condition, that is destroying the children + perpetuating alienation by the mother - of me in the children's lives. Evidence of this is Judge \_\_\_\_\_ stated quest, (on the court record) at our most recent court appearance to the current date, to find a new "Master's level" (She said the court probably couldn't afford a better level, such as a PhD, because of the State's current economic condition.) Therapist for new evaluations.

3) Judge \_\_\_\_\_ threatened me with removing my parenting time, (as she said she has in other cases) because I have had to on several occasions, utilize law enforcement to enforce Court Orders that the children's mother refused to abide by, to make the violations a Record, because there has been no relief or enforcement in the court system.

age 11, hearing this Judge degrade their  
Father, though I only request relief over + over from  
the children's mother violating Court Orders.

4) Judge also as much as called 'me' abusing  
the children, because she let the children sit in the  
courtroom and hear me testify that the children's  
mother was an Alcoholic with Borderline Personality  
Disorder, diagnosed as Bi-Polar as a child, causing  
the children to miss 24 days of school just in the  
2009/2010 school-year up to January 2010 because  
she obsessively takes them to multiple doctors +  
therapists without my knowledge or permission (another  
violation of Court Order) medicates the children at  
her will + inconsistently and with medications (on Dr's  
records) that are harmful to them, and alienates me  
their father, by coaching, coercing + scaring the children  
into lying to achieve her objectives of having the  
children hate me; and I said she was an 'unfit mother'.  
For this, she Judge asked a Psychologist  
for over 35 years, questions in such a way as to label me  
as an abuser. All of this in front of my little children.

5) Though not one bit of evidence against me has been  
presented, with accusations of me already tried in Superior  
Court by Judge on Jan 8, 2010, Judge  
has joined with CPS to make a case against me that doesn't  
even exist, only allowing therapeutic supervised visitation with  
my children for me, <sup>(Attach additional sheets as needed)</sup> but allowing the children's mother, unrestricted  
contact with the children, thereby again proving all the above  
facts.
