ORDER

The complainant alleged a superior court judge was biased, conspired to take away his children, and issued incorrect rulings. The commission reviewed the matter and found no evidence of ethical misconduct on the part of the judge. The claim that the judge ruled improperly raises a legal issue outside the jurisdiction of the commission. The complaint is dismissed pursuant to Rules 16(a) and 23.

Throughout this whole case I have endured nothing but extremely bias and prejudice attitudes from every member in the court room. Everyone treated me as though I was guilty and the Judge never tried to allow me to present my side or listen to what I had to say. Due to his ignorance and misinformed Judgments he has placed my kids through neglect and abuse in the CPS system. A prime example of this is when the matter of placing my kids in the care of their Aunt Laura; my wife and I along with our lawyers pleaded to not place them in her care but our input was not taken into account. CPS claimed that she was approved by the standards and that was all Judge [redacted] wanted to hear. In the Aunts care my kids were not fed or provided with necessary supplies to live (deodorant, shampoo and feminine products). They were threatened to be killed on several occasions by the Aunt and she even struck my oldest then dropping them in front of a CPS office. A few CPS officials then placed my kids into hiding due to the threats given by the Aunt even though she was approved by both Judge [redacted] and CPS as a better alternative than back with their parents.
