**ORDER**

The complainant alleged that a superior court commissioner was biased, awarded attorney fees out of spite, failed to consider motions, and made incorrect legal rulings. The commission reviewed the allegations and found no evidence of ethical misconduct on the part of the judge. The investigation revealed that the complainant repeatedly submitted non-compliant documents, failed to serve other parties, and did not state a basis for the relief she sought. The complaint is dismissed pursuant to Rules 16(a) and 23.

9. \_\_\_\_\_ knew that I was on to her corruption and she stuck me with a \$56,000 attorney bill that should have been paid out of my husband's Trust. She was attempting to shut me up.
