**ORDER**

I was given a notice to come to court on 6-9-2010 at 4pm to come to court on 6-11-2010 at 9am. I informed the Judge that I needed more time to put my case together because I did not have time to do so. I only had one working day and that day was 6-10-2010. The judge told me at the start of the case that I had enough time and the case will go on. My extension was denied. During the case the Plaintiff stated a large amount of untrue statements without any proof of beside the Plaintiff's untrue statements. During the case I had almost no evidence to give to the court sent mainly because I had no time to put my case together. At the end of this case the Judge told me that something like the Plaintiff is a fraud if you can't see it. For the record the Plaintiff has never given any evidence to back her case up. The Plaintiff just lied under oath and under penalty of perjury to get the judge to side with her. After the judgment was given I simply asked for an appeal and the judge stated she will give it but she does not feel she was wrong with the judgment, also the judge give the Plaintiff an order of protection from me. Once more the Plaintiff has not given any evidence to her untruthful statements. On the same day I paid for a cost bond to stay at the apartment so I could get ready for the appeals. The judge set the amount that I had to pay to stay which \$2,336.?? I had until the 5pm to pay it and I did pay the full amount and the judge approved it and they took my money and told me this was the clerk who stated this that I would pay next month rent to the court and not to the apartment/Plaintiff. On 7-1-2010. and also I asked the clerk the one that is the head clerk also for the record did I need to fill out an address change form and the clerk said no because you're going to post bond right and I said yes.

In the station I tried to show them the cost bond papers I had to show them I had a right to be here, at the news and the cops told me what and left because of the cost bond papers. On 6-15-10 I was called to show up to court at 3:30pm to talk about the cost bond. Even though the judge approved the cost Bond and clerk also. The judge stated I could not be there and the clerk stated she did not tell me I would be able to stay there. The clerk lied on the court and the Judge lied because she is the one who approved the cost bond form for me to stay. Told me I had it his to get and not to come back. Oh on this day I was not able to bring evidence to the court the judge said we are not doing that. On 6-15-2010 was unable to question the Plaintiff, the judge stated <sup>I'm</sup> not doing that again, and would not let me put audio and video of conversations to 110% prove the Plaintiff was and is a liar, also under Az Law only one party of the conversation needs to know it is being recorded and the Judge still said no. I could only put e-mails and the real amount of time me and the plaintiff had contact. In the order of protection it states that I would send threats and demands the email I give the judge all of the e-mails and not a email had any of that in them, also I give the judge the call history and the breakdown of all the real times me and the Plaintiff had contact.
