ORDER

The complainant alleged that a superior court judge wrongly sent an innocent man to prison and improperly denied his request for change of counsel. The commission reviewed the allegations along with the additional information submitted by the complainant and found no evidence of ethical misconduct on the part of the judge. The issues raised involve legal matters outside the jurisdiction of the commission. The complaint is dismissed pursuant to Rules 16(a) and 23.
