ORDER

The complainant alleged that a superior court judge demonstrated bias by ignoring her evidence during two hearings. She further alleged that the judge was involved in a conspiracy against her because he owns a restaurant and has possible connections between various witnesses and the court-appointed advisor. After considering the issues, the commission found no evidence of ethical misconduct on the part of the judge. Accordingly, the complaint is dismissed pursuant to Rules 16(a) and 23.
