ORDER

The complainant alleged that a superior court judge demonstrated bias by allowing the victim to lie and the prosecutor to behave disrespectfully. He further alleged the judge made incorrect rulings. After analyzing the issues and reviewing the recording of the hearing, the commission found no evidence of ethical misconduct on the part of the judge. Allegations involving the judge's rulings are outside the jurisdiction of the commission. Accordingly, the complaint is dismissed pursuant to Rules 16(a) and 23.
