**ORDER**

The complainant alleged that a justice of the peace improperly allowed a case to proceed despite her proper request for summary judgment. After reviewing the allegations, the commission found no evidence of ethical misconduct on the part of the judge. Based on the online docket and confirmation with the court, the judge dismissed the case after conducting a hearing. Even if the case had proceeded, the decision to deny or grant the motion for summary judgment involves a legal issue that is outside the jurisdiction of the commission. Accordingly, the complaint is dismissed pursuant to Rules 16(a) and 23.

**COMPLAINT AGAINST A JUDGE**

On February 14, 2008 HSBC had illegally and unlawfully declared me dead. They got confused in a telephone conversation with my husband Sr., who had told them to cease and desist. They interpreted this as deceased. It caused financial hardship and personal grief, for an automotive dealer in Phoenix Arizona who was running my husband's credit, had informed him that I had been declared deceased. He had panicked and was extremely saddened and worried about what happened to his wife that he has just seen this morning before leaving to buy a new vehicle. After several distraught hours he was able to get a hold of me and find out that I was fine and that there is a mistake on my credit report. HSBC after being forced to reconcile their mistake by the Attorney General of Arizona, Attorney General of Illinois, and the Office of the Comptroller they finally settled. However this complaint is about the hardship and civil lawsuit that they have filed against me in the State of Arizona in Mohave County Cerbat Justice Court in the city of Kingman. They have filed this after this matter was resolved their Attorney Firm they have hired Gurstel Staloch & Chargo whose representatives Michael Sneberger, Jennifer Wiedle, Daniel A. Donze, Jenö Berta, Andrew J. Westle, Valerie Dilliard, and an individual named Aaron who would not supply his last name. Has declared this settlement agreement has no standing and they have the right to sue on HSBC behalf. The potential crimes that they may very well be guilty of are extortion, harassment, breach of Contract, Identity Theft, Fraud, and financial terrorism. On December 09. 2010 after supplying evidence that all of my accounts have been settled with HSBC with the assistance of the Attorney General of Arizona, Illinois, and the Office of the Comptroller. It was clear that Gurstel and Chargo had frivolously and fraudulently filed. So after an hour in the court their legal representative Andrew J Westle said in open court that they may have been suing, harassing, and attempting to extort money from the wrong account number, and account holder on behalf of HSBC. As well LIED in open court that they never received a COPY of SUMMARY JUDGMENT dated

September 15, 2010 and signed by them on September 16,2010 which would be perjury. Of which the Justice of the Peace acknowledged in court however allowed him to continue with their lies. Then he had asked the Justice of The Peace to give them an opportunity to continue their pursuit of extortion, harassment, breach of Contract, Identity Theft, Fraud, and financial terrorism against me. The Justice of The Peace had agreed with them. That even though they did not respond in time as applicable by law, nor did they specify a claim against me with any evidence on the record, proof of claim, or lawful authority. That they would be given the opportunity to pursue this matter against me. This clearly violates the settlement agreement with HSBC which was completed with the assistance of the Attorney General of Arizona, Attorney General of Illinois, and The Office of the Comptroller. It appears Justice of the Peace believes he has superior authority over the Attorney General's of Arizona and Illinois as well as over the Federal Government Office of the Comptroller. He must be stopped and punished for what they have done to me in the past and are currently doing today.
