**ORDER**

The complainant alleged that a superior court judge should not have allowed the county prosecutor to interfere with his efforts to have his civil rights restored and his charges decreased to a misdemeanor. The commission found no evidence of ethical misconduct on the part of the judge. Whether the prosecutor acted properly is a legal issue outside the jurisdiction of the commission and more properly addressed through an appeal. Accordingly, the complaint is dismissed in its entirety pursuant to Rules 16(a) and 23. Judge J. William Brammer and Sheila Polk are no longer members of the commission.
