ORDER

The complainant alleged that a superior court commissioner violated his rights by finding him mentally ill and requiring him to be forcibly medicated. The commission reviewed the matter and found no evidence of ethical misconduct on the part of the judge. Whether the commissioner made the proper determination is a legal question outside the jurisdiction of the commission. Accordingly, the complaint is dismissed in its entirety pursuant to Rules 16(a) and 23.

On January 19, 2011, at a hearing held before the Honorable
 my rights were, once again, spit upon by an adjudicator affiliated with the Superior Courts of Arizona. I was not allowed to summon any of the many employees of the Arizona State Hospital who have volunteered their creditable testimony in my behalf. I had given their names to my court appointed representative, Bernardo Garcia. He refused to answer me when I asked him why he had not summoned them. Mr. Garcia also would not present a document I had given him to enter into evidence in support of my defense.

When the 3 of the 4 state employed witnesses perjured themselves on the witness stand Mr. Garcia ignored my attempt to prompt him to ask questions until Michael Breslow had finished his false diatribe on my deficient character and terrible illness. When Mr. Garcia asked me if I had questions I demonstrated to the court that my behavior has never been anything but appropriate to my situation.

I was allowed to take the stand and speak. I began by informing the court that I had been granted leave to procede Pro Se in litigations in federal court (U.S. District Court for Arizona). I stated that Michael Breslow was lying in his affidavit to the court and that he was lying on the stand. My attorney ask one question as I recall, Then, before I could tell the court that the 3 perjurers were all defendents in the federal court case filed Dec. 22, 2010. I was ordered off the stand, denied any redress of the false statements made by Michael Breslow, Geri Sanders and David Obergfell. Without any just cause I was declared mentally ill and ordered forcibly medicated. If you would trouble yourselves to review the audio recordings you will hear that the

only factually stated cause for ordering forced medications is that I have been pursuing my rights via legal means. If you will recall, in June 2010, I was, under very similar circumstances, declared ill and forcibly medicated by order of Commissioner/Judge Hintze. I still have a headache because the unwarranted, harmful drugs used were misused and seem to have done some, hopefully not permanent, brain damage. The headache began in July 2010 and has continued unabated since.

Let us review: 5 Judges have denied me my rights to present evidence, confront witnesses or even to speak in their courtrooms.

- There have been 12 doctors/psychiatrists that did assessments and then lied to the courts in those reports.
- I have had 10 different attorneys appointed to represent my rights and not one of them have summoned a single witness, nor presented a single page of the VOLUMES of documents, as in school records, military service records or documents from employment, written statements and testimonials that demonstrate that every doctor and nurse and social worker that has lied to the courts.

No ONE WHO HAS TALKED TO ME FOR AN HOUR HAS TOLD ME THEY BELIEVE I AM ILL, except the doctors and nurses who have lied to the courts.

Yesterday, the State Bar of Arizona's Patricia Ramirez told me the Bar was going to step back and wait on the outcome of the Federal suit before she takes any action.

On about January 27th, 2011, the day after I was assaulted and forcibly medicated, I began to bleed from my nostril and there is, once again, blood on the toilet paper. My memory is being impaired, possibly damaged permanently. Again, a rash has erupted over my entire body. I itch. The defendants employed at this facility have refused to accept the notice of complaint and submit a waiver of the service of summons.

Although the Clerk of the Court has returned copies of the complaints, motions and orders, stamped and dated as filed, I have yet to receive any signed orders or decisions from the U.S. District Court, other than the leave to proceed. (Nov. 2010)

All the while the defendants continue to impede my address of issues, refusing me access to gainful employment, recreation or even hot food at the dining room. I am kept confined on a locked ward for 23 hours a day, seven days a week, refused contact with family, friends or any other visitors. I am daily insulted and abused by staff and was done serious bodily harm when I was assaulted and forcibly medicated on Feb 10, 2011. The U.S. Attorney's office advised me to file a police report. I have twice demanded the police be summoned after I was assaulted and have been refused even the phone switchboard operator will not let me call the police. The staff tell me they have been ordered not to make copies. No one, NOT the "Bar", not your "Commission", not the Superior Court or even the U.S. District Court has lifted a finger to stop this heinous crime against a law abiding citizen. Even my family has withdrawn in fear, anger and frustration. Every person that has volunteered testimony and support has reported being harassed, threatened, then their phones get disconnected and I have not heard from them of their families since. I do not know what is happening with my friends, my neighbors, or my family. I, nor anyone else, understands why every doctor has lied and every judge and lawyer, Bar counselor and Commissioner is helping them get away with it. Nor why the U.S. Dept. of Justice would tell us they lack the resources to deal with my complaints. I do not care about "WHY".

What I do care about is the fact that I have come to believe a genuine threat to the Constitution exists. I also believe that the Creator gave us our Constitution and the Bill of Rights and that they will not perish from the Earth. The WAY is life and love.
