ORDER

The complainant alleged that a superior court judge conspired with the prosecutor's office to violate his rights and deprive him access to discovery materials. The commission reviewed the allegations and found no evidence of ethical misconduct on the part of the judge. The complainant did not provide any specific examples or allegations as to what he did not have access to or why he believed the judge was working with the prosecutor. Accordingly, the complaint is dismissed in its entirety pursuant to Rules 16(a) and 23.
