On March 11, 2011, we were locked out of our home thus violating several court procedures including our appeal LC2010- . The plaintiff Beulah Sita Barge Jackson has never paid the appeal fees, thus negating her right to appeal my appeal as the Defendant. Furthermore per Chandler Police Report# 99- when her relative Chandler Officer Brian J. Hunsaker came to supposedly investigate the robbery of my home, Hunsaker decided that he was going to steal the deed to my residence of Phoenix, Arizona then decided to also steal the preliminary copy of my escrow papers of a home that we purchased in Maricopa located at Maricopa, Arizona . When Hunsaker stole this set of papers, keeping in mind that he is a relative of Elizabeth Ward and of plus Beulah Sita Barge Jackson that he gave those papers to his friends so they could illegally reassign my property to the name of Jackson whom with had stolen the deed to the property in 1978 and to the address of Phoenix, Arizona when his mother decided that she was going to illegally live in both houses to nullify a lease agreement to P & H Realty in an attempt to defraud myself out of the funds that I am entitled to be paid per the agreement of \$294.69 per month for the Hunsaker, Jackson, Johnson the judge whom lied and apparently did not record the deed in his attempt to defraud myself out of my property plus David Cutler of whom had attempted to misidentify me as the person that he was very involved in a physical relationship with on several occasions as the person that was living in my dad's mobile office located on said premises. I am the owner of the property, not the person that had several affairs on the property while Pamela Lynn Sharp Gersheimer and Julie Ann Taraba Gersheimer Isham Sulley Bischoff two different persons had a VW Beetle that they had stolen from Bonnie and Jim Henley of the 7th Street location where apparently the duo who had stolen my school ID had attempted To lie to say they were myself. During the entire time they were living in their plethora of disgust with living illegally on my parcel. I was attending ASU on a leadership scholarship then living with my parents, paying my own expenses, running my parents Business and working outside for extra income. Thru comments that and his girlfriend Jackson have made, they are attempting to fabricate some BS that they are providing for my family and I when infact they have been keeping my family from earning a living as well as have tried to kill my family and I a few times with different methods such as poisoning from contaminated sugar that was turned into Phoenix PD to on May 13, 2008 when both and Jackson pulled down a huge box in a container in an attempt to kill me at Federal Express. They were also asked during this time of why they were on my property on 11th Street as well as they were reminded that I still owned the property even though they stole the deed and other copies in multiple robberies that they had committed along with Cheryl Jackson another disgusting thief

that now tries to say she is a realtor that breaks into houses when her key does not work properly. The above people are now into the Superior Court with their little game of their relatives with their hiring a judge named Eartha Kitt Washington, yet another case of misconduct and biasness against myself and family since we are the true owners of the property. This time on the court paperwork itself, even though the police report of the stolen deed had been entered into the packet, I was locked out and attacked. No court papers were ever brought forward, just another case of judicial misconduct from a very unstable and corrupt judge name _____ and his family of criminals.

When we were locked out we were not even given any court paperwork, just hit with tasers, screamed at by _____ and his girlfriend Jackson with her daughters continuing to say that they were going to kill us and make us into robots filled with Jackson's drugs so her and her daughters could sell us. These are not the normal things to have said to us so we kept the doors and windows locked while we were under siege with the persons banging on the doors, windows and trying to come in thru the basement while they had their meth lab going on under the floor.

Keep in mind they are eviction, they have no right to contact us even though it has come to mind and has been said to us that Jackson, her daughters and _____ all were saying that they were our caretakers when infact they are hated enemies since the days of Chicago in 1966 when _____ and his gang of Panthers/Weatherman had shot me in the back of the head in an assassinate attempt then went on to loot and steal from our home in Lyons, Illinois. Hunsaker was involved in this group with his relatives Davis and they were all evicted from a tenement run by the Chicago Housing Authority when the Chicago SWAT and National Guard came to regain order from all the looters, and illegal occupants from their gang. This is no different than what they have done to our family. I thoroughly dislike and I always have disliked these people, they have constricted me with their radios like people use to train a dog then will start to cause further pain in different areas.

Now as of late they are trying to further extort funds etc while they are attempting to say they are involved with my daughters twin brother that was stillborn and trying to get his rightful property. I simply cannot explain the pain and sorrow that this brings since I had held him after he survived for only 5 days when he was reported to be deceased from Good Samaritan Hospital wracking up over 500K in medical bills after we called in even more specialists. I paid over \$3500 for the final expenses and he was laid to rest in the Cemetary at 27th Avenue and Van Buren. I paid for all the markers etc, but it was reportedly stolen when he was laid to rest. Jackson and his Cutler family was at the hospital the day that he suddenly became sick and had to be transported to Good Samaritan, he was then found to have suddenly to get worse immediately. They were at the hospital so they could visit the nurse that had beaten me the night before when she started yelling at the top of her lungs that Birth's in America are the safest in the hospitals, and she said she was going to see that I suffered the most painful dangerous birth of my children of all to make me one of her statistics of mothers that had the fatalities. They had deliberately given me medication I was allergic too as well as to cause huge birth injuries to my son and daughter.

With this in mind I really reflect back and really detest the fact that we made the mistake of attempting to be kind and assist the Jackson family with _____ in their time of need since all they did was to rob us. This entire case is a case of misconduct entirely and they all need to be imprisoned for their fabrication of medical and other records. They have really damaged my credit, and income. They will all be held liable for the disgusting acts that they have always committed.
