The complainant alleged that a justice of the peace improperly allowed a car to be seized and forfeited. The commission reviewed the matter and found no evidence of ethical misconduct. The primary issues concern whether the judge handled the asset forfeiture proceedings properly, which is a legal issue outside the jurisdiction of the commission. Accordingly, the complaint is dismissed in its entirety pursuant to Rules 16(a) and 23.
