**ORDER**

The complainant alleged that a superior court judge violated the law by continuing his arraignment, conducting the proceeding without him being present, and then falsified the court record to show he was present. After considering the allegations and reviewing the record, the commission found no evidence of ethical misconduct on the part of the judge. Procedural errors by a judge fall outside the jurisdiction of the commission. The claim that the judge falsified the record is entirely unsubstantiated. Accordingly, the complaint is dismissed pursuant to Rules 16(a) and 23.
