**ORDER**

The complainant alleged that a justice of the peace violated his rights and predetermined the outcome of his case because of racial bias against him. After reviewing the complaint and listening to the recording of the hearing, the commission found no evidence of ethical misconduct on the part of the judge. Whether the commissioner improperly excluded relevant evidence and testimony is a legal issue outside the jurisdiction of the commission. Accordingly, the complaint is dismissed in its entirety pursuant to Rules 16(a) and 23.

Neither did she even question or tell him that certain steps that might be wrong from that specific time. I however did not sign that plea bargain, because many facts have been inconsistent. Judge \_\_\_\_\_ had even witnessed Sebrina Shaw insisting that I be examined by a "physician". Adding unnecessary inconvenience toward me, when I am not mentally challenged. Sebrina Shaw is only an attorney that was appointed me, though I specifically chose to defend myself. Beside that trial dates keep expanding and the change
