ORDER

The complainant alleged that a justice of the peace refused to allow him an opportunity to present his case during an order of protection hearing and issued an improper ruling.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After reviewing the allegations made by the complainant, the members of the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. The commission has no jurisdiction to determine the legal sufficiency of the judge's decision. Accordingly, the complaint is dismissed in its entirety pursuant to Rules 16(a) and 23.

To Whom It May Concern:

I wish to file a complaint against Judge _____ of the North Valley Justice Court in Surprise.

In November, 2008, Stephen _____ of Surprise got the Judge to grant an Order of Protection against me by committing perjury--the case # was CC2008.

While the Judge's order was in effect, and for more than a year after the order expired, Mr. _____ and his wife, Kathryn _____ repeatedly attempted to contact me and provoke a rise out of me. During this same period, I made no attempt at contacting Mr. and Mrs. _____

All of this finally came to a head in November 2010. At that time, more than two years after the Judge issued his order to protect them from me, the _____ began harassing my friend Carl _____ who lives in Chicago and does not know the _____ family. Carl has never spoken of them, nor has he ever tried to contact them. At that point, I contacted the Surprise police.

Officer Michael King of the Surprise police visited the _____ home, at which time _____ my former housemate, who lives with Mr. and Mrs. _____ admitted that the 40 or so inflammatory messages & blog comment postings that were sent to Carl indeed came from within the household. I'm happy to put you in contact with Mr. _____ so you can verify this.

A month later, in December 2010, Mrs. _____ posted a video about me on You Tube that was so dangerously inflammatory that Officer King returned to the _____ house. The video was deleted from You Tube within five minutes of the officer's arrival at the house--I still have a copy of that video archived on DVD.

During the hearing for Mr. _____ request for protection, I was not allowed to speak or present documentation, but Mr. _____ was allowed to speak as much as he wished--I have a CD of this hearing and can make copies for you.

Fore more than two years, Judge _____ and his office was repeatedly informed by me that Mr. and Mrs. _____ were harassing me. As recently as two months ago, the Judge refused to do anything about Mr. and Mrs. _____ outrageous conduct. The Judge granted Mr. and Mrs. _____ an Order of Protection against me, then knowingly allowed the _____ to harass me to the point of madness for more than two years--though the _____ hate campaign against me actually began in 2006. Had Officer King not stepped in, the _____ would still be coming after me today.

I feel that any judge who would intentionally enable a situation like this should be removed from the bench and held further accountable.

I hope you will also hold Mr. and Mrs. accountable for committing perjury and for using the North Valley Justice Court in pursuit of a personal vendetta. I also request that, under these circumstances, the Judge's order against me should be stricken from your records.
