## ORDER

The complainant alleged that a superior court commissioner had him illegally arrested on charges the commissioner trumped up. He further alleged the commissioner has improperly controlled his court-appointed attorney and wrongfully denied his request to fire the attorney.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the commissioner engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After reviewing the information provided by the complainant and various court records, the members of the commission found no evidence of ethical misconduct and concluded that the commissioner did not violate the Code in this case. The commission has no jurisdiction to determine the legal sufficiency of the commissioner's decisions. Accordingly, the complaint is dismissed in its entirety pursuant to Rules 16(a) and 23.

Dear Member of Commission:

Yesterday evening I have given more thought to the matter, and I have come to the conclusions as follows:

- I believe you need to investigate the involvement of Judge (Maricopa County Superior Court, room 1303) in both of my cases, S-0700-CR-2008 (case 1) and S-0700-CR-2009 (case 2), especially the latter. I believe Judge knew what persons had illegally entered my apartment at Road and committed those crimes of hoax calls, for which I was later wrongfully sentenced. I wonder, what was the Judge's real involvement in those crimes? Was the judge an accomplice of the criminals who committed those crimes? Consider:
- 1) He took my hand-printing (which Detective Brown forced me to put and later presented as my "signature", see my earlier reports on the matter from the attached copies) for a "signature of confession", and ordered to arrest me on Sept 29, 2009, which was a wrongful arrest.
- 2) He later ordered to arrest me again on June 15, 2011, which was again a wrongful arrest. My attorney Tammy Wray with Public Defender Office said to me that this was a "delayed jail time", not an arrest in my municipal court case. I wonder, how can the Judge give me a "delayed jail time"? For what?
- 3) Later on September 14, 2011 he issued a nervous, hysterical court order, which I have described to you. You have a copy of it from the attached papers.
- 4) He denied the dismissal of my attorney Tammy Wray, claiming that my request doesn't have enough "merit". In reality, as a friend of mine has told me, I do NOT need to present any reason to dismiss my court-appointed attorney. The Judge made a mistake when he denied my request to dismiss the attorney. He later promised to give me a copy of the dismissal decision same day on September 14, 2011, but I never received it.

I hereby request to DISMISS my attorney Tammy Wray as my probation attorney and Judge as the judge for my probation, and appoint a different Judge and a different attorney. I wonder if Judge gives attorney Wray secret instructions so as to have the said attorney provide since he apparently is not going to dismiss himself, and re: the attorney, he already pronounced his wrongful decision to me on September 4, 2001, after he did not allow me to finish explaining, why I believe that this attorney should be dismissed.

I request to investigate this report and have the Judge arrested if there is enough reason to believe that he was involved in these crimes, or if he KNEW who committed them, but still ordered my arrest on September 29, 2011, basing on a piece of my hand-printing which the investigating Detective (Brown) presented to me as my "signature of confession". I have a HUGE circumstantial evidence against the Judge and Detective Brown, this evidence is much BIGGER than what the prosecutor's side presented against me. They did not present ANY direct evidence, only a circumstantial evidence. You could forward this report to the police for their investigation. I had in the past talked with the police on a related matter and was told (by Sergeant Hudson with Phoenix Police Pro Standards Bureau) that I first should submit similar reports to the judge or judge's supervisor before contacting the police.
