ORDER

The complainant alleged that a superior court judge favored the prosecution in his criminal cases.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After reviewing the information provided by the complainant, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. The commission does not have jurisdiction to investigate the legal sufficiency of the judge's rulings. Accordingly, the complaint is dismissed in its entirety pursuant to Rules 16(a) and 23.

I WOULD LIKE TO TAKE THIS TIME TO FILE A COMPLAINT AGAINST THE HONORABLE JUDGE. EVERYTHING STARTED FROM THE FIRST DAY OF TRIAL WHEN THE JUDGE WAS ALLOWING THE PROSECUTOR TO OBJECT TO THINGS THAT MY ATTORNEY WAS FIGHTING ON MY BEHALF AND EVERYTIME MY ATTORNEY OBJECTED TO CERTIAN QUESTION THE JUDGE WOULD ALLOW THE PROSECUTOR TO KEEP GOING. FROM THE START OF THE TRIAL THE JUDGE SHOWED HIS TRUE COLOR AS FOR THE JUDGE IS ALL FOR THE STATE AND WAS HELPING TO GET A CONVICTION. THE JUDGE ALLOWED THE PROSECUTOR TO BRING IN STUFF A WEEK BEFORE TRIAL AND WHEN MY ATTORNEY TRYED TO KICK IT OUT THE JUDGE STILL ALLOWED IT. ON MARCH 6, 2012 I WAS ATTACKED AND RUSHED BY THE VICTIMS FATHER AND EVERYONE IN THE COURT AND VIDEO WILL SHOW IT WHEN YOU LOOK AT IT THAT THE BAILIFF TACKLED THE VICTIMS FATHER TO THE GROUND AND THEN THE LEAD DETECTIVE ON THE CASE CAME TO HELP AND TAKE HIM OUT. MY LIFE WAS IN DANGER AND I WAS THREATENED AT THAT TIME MY ATTORNEY ASKED FOR A MISSTRIAL THE JUDGE DENIED IT. THEY TOOK THE WHOLE JURY OUT OF COURT AND BROUGHT ONE IN AT A TIME TO ASK QUESTION ABOUT IF EVERYONE SAW WHAT HAPPEN AND IF ANYONE TALKED ABOUT IT AND ONE OF 15 JURY MEMBER ONE SAID HE HEARD 3 LADYS OF THE JURY TALK ABOUT IT AND THAT IS GROUNDS FOR MISSTRIAL AND THE JUDGE SAID NO. THE NEXT DAY I SPOKE UP IN COURT AND TOLD THE JUDGE THAT HE IS AN UNFAIR JUDGE AND I DONT WANT HIM TO BE MY JUDGE ANYMORE AND HIS ANSWER WAS IM DOING WHAT I THINK IS RIGHT AND THAT MY ATTORNEY IS DOING A GOOD JOB SO I STOPED HIM TOLD HIM AGAIN THAT I WILL REPEAT MYSELF TOLD HIM ON RECORD TWICE THAT I DONT WANT HIM AS MY JUDGE AND THAT HE IS NOT A FAIR JUDGE AND THAT HE IS TRYING TO HELP THE STATE PROSEUTION TO GET A CONVICTION AND AFTER THAT HE CHANGE A LITTLE BIT TO THE POINT WHERE HE COULD ARGUE

SEE I DIDNT JUST HELP OUT THE STATE. SO I WROTE SOME STUFF DOWN THAT I HANDED TO MY ATTORNEY TO READ AND PUT ON RECORD ON 3.8.2012. I AM TELLING THE JUDGE THAT I FILED THIS COMPLAIN ON HIM AND THAT HE IS IN VIOLATION OF RULES 2.4(A,B,C) EXTERNAL INFLUENCE ON JUDICIAL CONDUCT, VIOLATION 2.2 IMPARTIALITY AND FAIRNESS AND VIOLATION 2.3 (A,B,C) BIAS AND PREJEDICE. I ALSO WILL MENTION AND WOULD LIKE A FULL INVESTIGATION ON FUNDS THAT THE JUDGE WILL BE GETTING FOR HIS RELECTION TO HIS CHAIR TO SEE IF THE VICTIMS FAMILY HAD MADE ANY AMOUNT OF PLEDGE AND IF THE STATE PROSECUATION ATTORNEYS GENERALS OFFICE MADE ANY PLEDGE OR PROMISS TO HELP WITH HIS NEXT ELECTION TO THE SEAT. I WILL ALSO BE MENTIONING THAT I WANT TO PRESS CHARGES AGAINIS THE VICTIMS FATHER FOR ATTEMPT TO COMMITT AGRAVATED ASSULT AND THREATENING AND INTIMADATING ME AND MY FAMILY IN COURT, PLEASE GET A COPY OF COURT RECORDS AND COURT VIDEO TO SEE ALL MY PROOF AND AT THIS TIME I WOULD LIKE MY COMPLAINT THAT WAS FILED TODAY TO SEND ME A FULL DISCLOSED REVIEW OF WHAT THE COMMISSON ON JUDICIAL CONDUCT WILL COME UP WITH AND ALSO A LIST OF ANY OTHER CODE VIOLATIONS AND I WOULD LIKE TO ASK FOR THE JUDGE TO RESIGN HIS POSITION FOR BEING A BIAS JUDGE AND AN UNFAIR JUDGE WHEN HIS OATH THAT HE TAKES EXPLAINES CLEARLY THAT A JUDGE IS TO JUDGE IN THE STAND NOT TO PRACTICE AS AN ATTORNEY ON THE STAND, THE JUDGE IS ALSO VIOLATING MY DUE PROCESS, THE PROCESS IN ME GETTING A FAIR TRIAL.
