ORDER

The complainant alleged that a superior court judge made decisions in a child custody case that demonstrated bias against women.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After reviewing the information provided by the complainant, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. The commission does not have jurisdiction to investigate the legal sufficiency of the judge's rulings. Accordingly, the complaint is dismissed in its entirety pursuant to Rules 16(a) and 23.

COMPLAINT AGAINST A JUDGE

I would like this commission to review the court decisions of Judge _____ I sense that Judge _____ is rendering decisions wrongly against women who appear in front of his court.. I ask you to investigate this judge. Has he been hurt in the past by women in his life that he now wants to use the court system to hurt other women? I feel that this judge is unjustly taking rights away from women and giving rights to men who are not requesting. The father of my grandson did not request visitation rights; the judge took it upon himself to give visitation time to the father without considering the whole picture. I, the maternal was not even considered when my child (grandchild) was required to visit with a man he did not know. I have contributed more to raising this child and I am without voice. The father should have weekend visitations only, but the court thinks otherwise. My grandson needs emotional warmth that the father and his family do not provide. They don't show enough love.

I don't want my grandson to be hurt or killed because the Judge has a chip on his shoulder. The court has been asked to require drug testing for the father and his fiancée because we want my grandson to be safe at all times. If the court has to, please, please require mother, father, fiancée, and both grandmothers to test for illegal drugs. Also, we have begged the court to require that a full-size car seat be used when the father is transporting my grandson. They use a "booster seat" that research shows is not safe. The type of booster seat that research shows is safe is the high back type. The father of my grandson transports my grandson in a low back booster not safe for children under pounds. I an unemployed individual am willing to purchase a "car seat" for children weighing up to one hundred pounds. Yet the father and paternal grandmother are not willing to invest money with an age-appropriate car seat. A low back booster is not safe for my grandchild.

I will await your decision before I make plans to obtain signatures for petitions to be submitted to the voters of Maricopa County. My grandson's safety needs to be seriously considered. I will be traveling out of state and hopefully I will return safely. If I do not return safely, please, please investigate this judge.
