ORDER

The complainants alleged that a municipal court judge assisted the police in violating their legal rights.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

The allegations raised against an unnamed judge involve legal issues outside the jurisdiction of the commission. Accordingly, the complaint is dismissed in its entirety pursuant to Rules 16(a) and 23.

pulling up because J. Chichill called in backup
 Lady cop ran up with her tazer pointing it
 at my dad she put my dad in hand cuffs as that was
 going on J. Chichill was approaching the blazer truck with
 his gun down he approached the driver window he
 yells at me on the passenger seat pointing his
 gun saying Get the Fuck out of the car I did not
 say eney thing I just got out they throw me
 on the black top by three cops had he
 knee on my head they pulled my right arm beside
 my back where I can touch my hair behind my
 head then they put cuffs on me then they started
 taking stuff out of my pockets picked me off
 the ground by my right arm, started taking
 my belt off my pants well I was in hand cuffs
 I tell them what am I getting arrested for?
 was having trouble taking my belt off to loosen it up
 then she yells I am going to brake this belt I don't like
 theas type of belts, then she figured it out
 and got my belt off my pants were a lil big so
 they fell down around my ankles started
 to touch my peanos for 30 to 40 secouse
 I called her out on it I said dose it a man search
 a man and then she yells are you gay and goes
 back to playing with me

I finally get to pick my pants up then that police man has my belt he gives me back my belt. He yells at me to go sit by my brother I ask him what is ~~his~~ name he says my name is cop! I am kneeling on one knee.

I started to tell them about GOD and that they need to get rite with him because they were doing all that to me my family then that cop says to me in front of my brother Sins you are on your knees pray for us that we be ~~better~~ better cops I told him that you are all messing with us for know good reason and then they all shuted UP

Then they let my dad go with \$10000⁰⁰ worth of tickets my sholder and elbow and wrists was in ascruiamating amount of pain we went to the Maricopa County Hospital

I talked to A Social worker and a cheff of police they took a police Report Saposably We tryed to tell the FBI

The FBI ~~is~~ says they pick and choose cases We moved to Durango CO I got a Job at Iron Horse pizza I am trying to help my Dad to get his drivers Liscans back He sent them \$500.00 money order

the way and turned in to the church parking lot By the time I get to the church parking
lot there a about 5 cops these officer and a couple other cops

was the female officer who sexually assaulted my Brother I cross the street
to the church with my school Buder and they were surprised to see me and my dad and
brother were both in the back of the cop cars I asked them for there names and badge # and

I wrote it down in my school book a Janitor at the church had seen everything go down
in side the church he came out and the cops kind of Just showed him back in the
church after that the cops had to let my dad and Brother go but they wrote

us about \$700 in tickets they took my dad Drivers license and were trying to get it back
we sent them \$500 But the Bill went up to \$1190²⁵. I think the Judge who judged this
case is wrong for letting these cops get away with what they did. after

we left being pulled over By the cops we went to the maricopa hospital there they treated
my Brother for the cops sexually assaulting him and they where being ruff with Both my dad
and Brother and a social worker had to tell my Brother sorry for
what the cops did and the chief of police was down at the hospital to hear what
happend. Also I talked to the (F.B.I) and (internal affairs) my dad is planing
to file his federal case after he pays there money back Also He is disabed

started this all for retaliation for his family member over a restraining order
