ORDER

The complainants alleged a superior court commissioner mistreated them during a modification hearing.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the commissioner engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After reviewing the information provided by the complainants and listening to the recording of the hearing, the commission found no evidence of ethical misconduct and concluded that the commissioner did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23.

My name is I am the respondent in case I represented myself. I took my case to Judge so that I could have more parenting time with my daughter, and to reduce child support. Upon entering the courtroom and seeing Judge I knew that my case was immediately lost. This judge in some way or form has some sort of a personal vendetta or hate toward me. I do not know if this is due to my appearance, demeanor, conduct, or past encounter with this Judge outside of the courtroom. She purely will rule against me. I have stood before Judge three times...and three times have been ruled against. I simply believe that this Judge hates me or has some sort or spite against me. My family members also feel this way as well. They were present at the hearing and all three of them have told me so. This Judge was completely rude, condescending, and talked down to me as if I were some kind of a pest or nuisance. The judge was completely uneducated about the case and about the parenting time in particular. I tried to advise the judge that I have my daughter also on Tuesdays. She disregarded my comment and became extremely irritated with me. During the hearing I fought a lost battle. I already knew it. The Judge took over a month to come to a decision. This judge modified the case in a manor which I nor the petitioner wanted. She made changes to parenting time which I nor the petitioner wanted the schedule was already working for 2 1/2 years. She also made a holiday schedule was I did not ask for nor which any party wanted and which was already set. She also changed child support which I did not ask for nor any of the parties requested. She also set the dependent/tax schedule which I did not ask for nor any of the parties wanted due to the fact that it was already set. Also the petitioner will claim our child twice in two years due to the fact that the judge made a decision without being educated. The Judge was completely uneducated about the case and also made a ruling which not only strips me of Tuesdays every week every month ...which I advised the judge that I have my daughter on Tuesdays and she became extremely rude and upset with me for advising her!!! I went in for help and I left in tears. I petitioned the court by myself for more parenting time and to reduce child support. Instead I left stripped of days that I already had and a lot more child

support to pay!!! I purely believe that Judge hated me. I since have hired a lawyer and spent thousands on him. We have asked for a reconsideration...DENIED ... a new hearing....DENIED....and a reevaluation DENIED...My attorney says that Judge is favoring the mother pure and simple. I believe that this judge purely hates me out of the way I look or talk or has some kind of personal hate or spite towards me....I believe Judge is completely CORRUPT or has or had a some kind of buddy system with the other lawyer. There is now way that what happened to me in that court room is justice or upholding the law. I would like to have this judge questioned/investigated. There is NO way this judge can sit down and speak before a review panel and justify her decision. I am a good person and a good dad. I just want my equal share with my little girl. I have since spent thousands of dollars on attorneys and got nowhere. I have had a very close personal bond with my little girl, due to the fact that I raised her on my own since she was a baby. I now see her 7 days out of the month...Our relationship is under strain and it is very difficult for her and me emotionally. I am asking you for help...Please help me

I was going to give testimony for [redacted] in case [redacted] I was not allowed to give testimony due to the fact the [redacted] did not give enough notice that I was going to testify. I remained in the court room for moral support anyway. During this time I witnessed Judge [redacted] run her court. She is rude and condescending and talked down to [redacted] as if he were her subject or some "pest". He did not have an attorney like the other party. He represented himself. Judge [redacted] scolded my 14 year old daughter who was also there to give testimony. She told her to get out of her court room. My daughter coughed!! . Judge [redacted] thought that she was being rude. My daughter began to cry and exited the court room. This judge in my opinion is a complete feminist and has absolutely no interest in the well being of the father. Upon leaving the court house [redacted] asked me "how did I do" I did not have the heart to tell him that this judge was and is completely against him. I did not have the heart to tell him that he did well but lost due to the judge. Judge [redacted] had an intentional prejudice or some kind of a past spite against [redacted] which was clearly exhibited by her toward him. I immediately knew that his case was lost.
