**ORDER**

The complainant alleged a superior court judge arbitrarily overturned a prior decision, discriminated against him, decided a matter before allowing him to be heard, ignored the bias of a court-appointed social worker, and required him to pay for services he cannot afford.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After reviewing the information provided by the complainant and the electronic court records in the case, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. The commission does not have jurisdiction to review the legal sufficiency of the judge's rulings. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23.

ON FEB 10, 2010 JUDGE OVERTURNED A TWO MONTH OLD DECISION, THE PETITIONS WERE IDENTICAL. I HAD MY CHILDREN TAKEN FROM ME FOR ~~THE~~ DEMENTIA. I HAD PROVED THROUGH DR'S EXAMS I DIDN'T HAVE DEMENTIA TWO MONTHS PRIOR.

ALSO, IN COURT JUDGE ~~SHE~~ TOLD ME "I THINK YOU ARE MORE DEPRESSED THAN YOU ARE LETTING ON (I HAD A PHYSYCAL AND PSYCHIATRIC EXAM COMPLETED ALREADY) AND I WOULD BE VERY, VERY, VERY, VERY DEPRESSED IF I HAD HIV/AIDS." INSERT WOMAN OR BLACK OR ASIAN IN FOR HIV/AIDS AND IT'S OBVIOUS DISCRIMINATION. HIV PEOPLE ARE A PROTECTED CLASS.

ON OCTOBER 24, 2010 JUDGE READS HIS DECISION IN THE CASE BEFORE I GET TO <sup>GIVE</sup> MY SIDE OF THE STORY - BASICALLY - I HADN'T SPOKE YET IN COURT AND THE DECISION WAS MADE.

JUDGE WAS TOLD THE COURT APPOINTED SOCIAL WORKER WAS BIASED. HE IGNORED THIS. IN HER EVALUATION SHE HAD OVER 30 LIES IN IT THAT COULD BE PROVEN ~~IN COURT~~ BECAUSE THEY WERE IN WRITING.

JUDGE GIVES ME BACK MY JOINT CUSTODY RIGHTS, THEN SAYS KIDS ARE SCARED OF ME. ABSOLUTELY - NO EVIDENCE ~~OR~~ OR MENTION OF THIS IN COURT. ~~THE~~ JUDGE APPOINTS ANOTHER SOCIAL WORKER AT \$25 AN HOUR TO REINTRODUCE ME TO MY CHILDREN. HE HAS BEEN TOLD I WAS DISABLED, NOT WORKING, AND NO INCOME, I STILL HAVE NOT SEEN MY KIDS ALONE FOR 3 YEARS AND CAN'T AFFORD THE SOCIAL WORKER.
