**ORDER**

The complainant alleged a municipal court judge was biased, made legal errors, and failed to treat the complainant in a dignified and courteous manner.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After reviewing the information provided by the complainant, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. The commission does not have jurisdiction to review the legal sufficiency of the judge's rulings. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23.

I respectfully ask this Commission to investigate Tucson City Court Judge \_\_\_\_\_ for the following reasons: 1. Judge \_\_\_\_\_ decisions made didn't demonstrate competent legal analysis. 5. Judge \_\_\_\_\_ didn't act with dignity & courtesy on the bench when she addressed me. Judge \_\_\_\_\_ also made reference to my being in the court almost every week for a number of reasons please note the injunctions I got reference several parties in Tucson City Court. My husband \_\_\_\_\_ lived at an illegal halfway house unbeknownst to him and I over the following persons making a threat to to bodily harm to sex offender George Bidwell I reported it and we were forced to move.

When I moved into the property at 85746 immediately I had problems with Homeowners at

\_\_\_\_\_ When I went before Judge \_\_\_\_\_ she denied my request for injunction to protect me from harrassment, threats, intimidation, acts of criminal mischief, acts of criminal trespass, and criminal damage saying I'm a renter just move. After this decision was rendered I was terrorized on a daily basis when my husband \_\_\_\_\_ my son \_\_\_\_\_ were at work.

Please note the letter sent to our Landlord \_\_\_\_\_ when this didn't result in our getting evicted from our property

\_\_\_\_\_ filed a malicious false involuntary petition against me on 11/21/2011 which cost my insurance upwards of 10K. Incidentally on this same day I

reported a woman by the name of \_\_\_\_\_ for keeping 24k from a drug house that was busted next to her property located at \_\_\_\_\_ This petition was quashed on 11/23/2011. The parties listed above then used this false petition to get harassment injunctions against me in Pima County Justice Court and gave false swearing under oath to secure injunctions. \_\_\_\_\_ admitted under oath she was hoping I would be found mentally ill and that she knew the Involuntary petition was false. I was then petitioned by \_\_\_\_\_ with the same false allegations on April 19, 2012 it was denied on April 24, 2012. Had Judge \_\_\_\_\_ granted my request initially for harassment injunction these unfortunate series of acts wouldn't have occurred.

Because of the stigma of the involuntary petition & the petition for title 36 various Law Enforcement Entities are still perceiving me as an unstable person. And even though these parties should be prosecuted for violating AZ State for filing false malicious petition they won't do it. I am respectfully asking the Commission to hold Judge \_\_\_\_\_ accountable for her actions.
