ORDER

The complainant alleged a municipal court judge knowingly and maliciously violated his constitutional rights, threatened him with violence, and proceeded with a hearing without jurisdiction.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After reviewing all of the information provided by the complainant, the recording of the hearing, and the judge's response, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. The commission does not have jurisdiction to review the legal sufficiency of the judge's rulings. Accordingly, the complaint is dismissed in its entirety pursuant to Rules 16(a) and 23.

Judge stated multiple times that he simply did not care if I should appeal. He refused to inform defendant of the nature & cause of the charges against him, stated that he did not have to abide by the rules of Constitutions of the U.S. & AZ, accepted testimony of an incompetent witness, denied Cross Examination, threatened physical force & violence against Defendant for asking questions, and ruled on this case where No facts or evidence towards jurisdiction; valid cause of action; applicability of the statute; elements of the alleged crime were presented.

On top of all of this, he refused to even let Defendant enter a plea & began hearing without a plea even being entered.

This is incredibly shocking to see that Judge has so little understanding of even the most basic elements of our justice system. Judge, displaying such stunning incompetence, should be removed from his position immediately and reprimanded. The sheer arrogance Judge displays when he says to "just take it upon appeal" is appalling.
