**ORDER**

The complainant alleged two superior court judges were biased, violated his constitutional rights, and mishandled cases related to his family.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judges engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After reviewing the information provided by the complainant and various electronic court records, the commission found no evidence of ethical misconduct and concluded that the judges did not violate the Code in this case. Whether the judges were entitled to rely on criminal charges in making temporary custody decisions is a legal question outside the jurisdiction of the commission. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23.

I was told that while with his father he was involved with felony activities of his dad and subjected to multiple convicted felons. I have never been found guilty but this was a safer environment! Judge \_\_\_\_\_ has again endangered children. Judge \_\_\_\_\_ went along with my presumption of guilt in his court room. Where is fairness or justice here? Who cares about the children?

Judge had court when I tried to get custody of my children after my ex's live in boy friend committed suicide in their apartment on top of my ex. When the police came they noted drug paraphanelia in the home including scales etc. The police report was given to the judge. She left the children with my ex and did say my ex needed to attend counseling which she never did. My ex died Jan 2012, at which time the Navajo County Coroner noted extremely high levels of meth in her system, Alcohol and some prescription medications.

During counseling my children revealed the fear they had of the people coming in and out of the house, some that had threatened the children if they said anything and the trauma the children had been suffering from by living in a drug home. Judge did not act to keep my children safe even with proof. She did not find my ex in contempt of court for not abiding by court orders, and my children suffered because of it
