ORDER

The complainant alleged a superior court judge prevented him from presenting his case and allowed the opposing party to lie about assets.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After reviewing the information provided by the complainant along with the recording of the hearing, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety pursuant to Rules 16(a) and 23.

To whom it may concern; (I Pray everyday for equal justice)

First I would let the commission know that I have been in courts from the local level to the federal level. I have never in my life ever seen or thought such a court would exist like this in the U.S of America! IN 7 months I only seen the Judge 2 times very briefly, the first time I saw Judge _____ he just looked at me for a few seconds in which he gave me a very nasty look and rolled his eyes like a child! The second time was the day of the trial which I was late about 10-15 minutes in which when I walked in my wife was getting off the stand. I got to ask her one question about a 54000 check in which they lied to the court about. The court heard absolutely nothing from me about my side at all. Every motion I asked for I was denied including change of Venue, Case sensitive sealed files, continuance, marriage counseling etc. We have been married 35 years and I just came home and my wife was gone and stole my mothers whole estate and property of our own.

This investigation is still going on and during the 7 months on July 2, 2012 Slater got a paper from

Sherrills dept. that the criminal I _____

Investigation was over. Nobody contacted me or told me until the last day of the trial!

Meanwhile during the 7 months I was waiting for Sheriff's department to arrest her. They knew that was what I was waiting for.

After she left our residence in AZ. She thought that all my mothers estate was community property and then when she found out that all of my mothers estate was left to me the executor she ran to County Court to file for dissolution after all my mothers valuables were sold by her. She also acted as executor of my mothers estate. Now I will never be able to take care of my mothers last wishes! I know on the police reports she lied on, and she lied to the court, clerk, Judge, etc.

I Have never lied on a police report, or a court in my life. I had no say in any of this so called trial at all. I did not receive any help from the Judge or anyone including who lied to me from the very first time I talked with him. I got no due process and no rights at all!

I can let this committee know I was told I could not get any information to the court or Judge according to mizzelle but I dont believe it would have a made a difference.

I can tell you that there was lots of marital interference from relatives, and people on Facebook. This interference was from extremely rich people including my brother

etc. All involved in protecting from crimes he committed which I have proof, evidence in which he bribed, blackmailed, manipulated my wife into these crimes of stealing estate, she took evidence I had against him, she took all important papers such as Insurance, medical, wills, all the papers a person would have in their safe. Also she was allowed to get my credit report and send it over the internet!

I was told I could not get her credit report!?

When the judge said he divided the property all I got was to pay the line of credit of 56,000.00 dollars from Chase bank which is half hers. Everything else that he said I got was already mine by will, or gift. So, due to not getting any due process, or constitutional rights I'm going to lose everything I have worked all my life for because of about 5 or 6 criminals. Due to the lack of Mr. conduct our family is being destroyed, mother's last wishes will never happen. All due to 5 or 6 Criminals!

Also I never got to go to the order of protection hearing. In 3 decades I never saw a OoP that stated the reason as (he may have or may cause domestic violence after the case?)

Commission please be advised that this is just a fraction of the complexity of the legal problems this family has been going through but regardless there is NO excuse for a elected official to act as a dictator, and take all my rights away from me under the law. I would like to quote Thomas Jefferson
 "When you take away the Jury the tyranny begins"

This one man has destroyed a very good family that took over 35 years to build. This court cares more about people getting divorces then putting marriages above money. The divorces go through fast and they make alot of money and if the marriage stays together they lose money.

Also this law of no fault leave it wide open for fraud, theft, etc. All a person has to do is marry some one rich and then move to Arizona, wait out the correct amount of time of residence and their RICH!

I would like to add one more thing and that is if I was awarded the same as my wife, I still would be reporting this to the commission.

No one should be allowed this type of power. In my eyes should be treated as a criminal, and charged as a criminal but due to his position I don't know? but I know right from wrong.
