**ORDER**

The complainant alleged a superior court commissioner failed to instruct his attorney to provide him with certain reports and improperly placed him in an inapplicable program to restore his competency.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the commissioner engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After reviewing the information provided by the complainant, the commission found no evidence of ethical misconduct and concluded that the commissioner did not violate the Code in this case. The commission does not have jurisdiction to review the legal sufficiency of court rulings. Accordingly, the complaint is dismissed in its entirety pursuant to Rules 16(a) and 23.

I don't belong in society or population, in a neighborhood or in jail, or in prison, I need to be hospitalized indefinitely, any true professional judge or prosecutor can look at my cases and know that I am seriously mentally ill and doctors have confirmed this, but because of such a strong desire to incarcerate me, the judge and the prosecutor are just enforcing law on me which show partiality, which only provide me with injustice, and which only put me, and others around me in danger, because of my serious mental illness!
