ORDER

The complainant alleged a superior court commissioner demonstrated bias by allowing false evidence during a hearing and by denying him the ability to defend himself.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the commissioner engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After reviewing the information provided by the complainant, along with various minute entry orders available online, the commission found no evidence of ethical misconduct and concluded that the commissioner did not violate the Code in this case. The commission does not have jurisdiction to review the legal sufficiency of court rulings. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23.

The orders entered by _____ are still being enforced when they should not be therefore I am demanding an investigation be done regarding the conduct of the Commissioner and Attorney as well as consideration in correcting or entering new court order due to the fact I have made numerous attempts in court to have these matters looked at to be corrected and have been given nothing more than run around in how to get matter heard and then being told that matter cannot be heard after I follow through with what must be done per the court.

If this matter is not looked at and investigated I will notify press, Better Business Bureau, Govenor, Local Senators, Local House of Representatives, Local Supreme Court, Federal Congress (Senate and House of Representatives), Federal Supreme Court, and the President Of the United States of America.
