ORDER

The complainant alleged a superior court judge has been unfair and biased.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After review, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23.

To Whom It May Concern,

I am exercising my right to request a new judge, as described in Rule 42(f). My rights as a father have been infringed upon, and I have faced a considerable amount of discrimination and bias under the Honorable _____

I have been to court regarding parenting and child support for my daughter many times in the past several years, and each judge I have had has worked to make a plan that involved my daughter _____ best interest, and set forth a plan for growth where both of her parents are equally responsible for her and have access to her. When the Honorable _____ took my case, she went in the complete opposite direction; she took away the joint custody prior judges had awarded between the Petitioner and I, and made it impossible for me to see my daughter. She imposed a ruling that demanded a large and unrealistic lump payment and said I must report to jail if I am unable to pay it, without looking at my finances. She also imposed a ruling that made it impossible for me to see my daughter. She has put a stop to the positive growth being made in court. I have been unable to see _____ for months, and paternal relatives have also been unable to see her.

Besides this sudden and unjustified negative change in court (with the parenting plan, visitation schedule, child support, etc), the Honorable _____ attitude toward me has been very confrontational and biased, I feel that it is impossible for me to have a fair trial under this judge. Her rulings are not in the best interest of my daughter, and show a consistent pattern of discrimination towards me. I am requesting a new judge that will not have a personal agenda or personal feelings that get in the way, and who can provide me and my daughter with a fair trial moving forward.
