**ORDER**

The complainant alleged a municipal court judge committed an assault.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After review, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23.

RE: Assault/Homicide crime committed by Judge

To whom it may concern,

I'm writing to you to report an Assault/Homicide crime committed and confessed by Judge

On [redacted] I received a call from Mr. [redacted] about [redacted] Mr. [redacted] told me he was in a real bad shape, he said he assaulted a young man at [redacted] gas station at [redacted] and [redacted]. Immediately, I drove over Mr. [redacted] father house at [redacted] to see him. I found Mr. [redacted] had open wound on the middle knuckle of his right hand. I asked him what has happened? Mr. [redacted] told me he came to [redacted] and [redacted] to gas up his car [redacted] ago. He parked his car too close to the other young man's car. So, the young man walked toward to Mr. [redacted] to talk to him, and Mr. [redacted] punched the young man on the face, and the young man got knocked out on the concrete floor. Then, Mr. [redacted] got into his car immediately, and drove away as his victim lay on the floor unconscious. Mr. [redacted] confessed to me that he assaulted this young man for no reason other than he had a bad day. The victim was a [redacted] male in his [redacted]. Mr. [redacted] was very nervous, he shaken uncontrollable through out the night. He couldn't sit still for [redacted]. He looked out the window for every car that passed by his father house and afraid it would be police officer come to arrest him for the assaulted he committed at the [redacted] Mr. [redacted] told me he wanted to run away because he didn't want to be in jail if he captured. Mr. [redacted] kept begged me to drive him away from his father house to hide. I told him running away was not a solution. Then, Mr. [redacted] asked me drive him somewhere so he could think what he need to do to avoid being arrested. I drove him around the [redacted] and I was able to calm him down a bit, we ended up in the [redacted] restaurant in [redacted]. I called my attorney (Mr. [redacted] to report Mr. [redacted] crime to him. Mr. [redacted] told me I should get away from Mr. [redacted] because

he was a criminal. Mr. [redacted] did not let me go home, he begged me to stay with him. So, I stayed with him in the restaurant and listen to him as he plan out his defend, which he couldn't came up with any, except plead guilty if he captured. However, Mr. [redacted] still did not let me go home after we get back from [redacted] restaurant. He asked me to drive around his neighborhood one more time to make sure there was no police car park around to wait for him before he return home. I walked in his father house with him as he said "this night might be my last night of freedom". Then, I continued to stay with him at his father's house for few more hours. Mr. [redacted] couldn't get any rest as he continued to worry he will get arrest for his crime. My attorney called police and reported Mr. [redacted] crime that night as he couldn't reach me, and he was afraid Mr. [redacted] might harm me also. There were [redacted] came and took the report, but they said the victim has not come forward to report the incident yet.

Mr. [redacted] called me again the next morning, he said "I'm very happy and relief after watching the news on TV, and no one seems to report the incident at the [redacted] where I assaulted that young man". He also said "I believed I got away from the crime I committed, and I knew I committed such crime". A "Homicide" case was noted according to Mr. [redacted] because he believed he could killed the innocent victim. Mr. [redacted] had asked me numerous times not to talk to anyone about his crime as he said it was his darkest time of his life. Also, Mr. [redacted] always discussed with me how he learned a lot through his judicial seminars/conferences of many ways of "criminals get rid of evidences" after the crime committed.

I have discussed this crime to [redacted] on [redacted] around [redacted], and I spoke to him again briefly on [redacted] advised me to file a complaint to Commission on Judicial Conduct about this crime. He also said he will check into this crime in the mean time.

As you may know, a "hit and run" incident didn't get report, it doesn't mean the crime didn't commit, especially, if the victim had died as the result.

I'm writing to you to request for proper investigation for such crime committed by Mr. [redacted] and appropriate justice should be taken into consideration without being prejudice of the title Mr. [redacted] currently hold.

Also, I reserved the right to publish my story with this complaint, along with the outcome of this complaint to media, and national broadcast news base on the true story of a Arizona Judge [redacted] committed such crime as he thought he could be above the law.
