ORDER

The complainant alleged that a superior court commissioner inexplicably refused to correct an error that kept him in prison well past his release date.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the commissioner engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After review, the commission found no evidence of ethical misconduct and concluded that the commissioner did not violate the Code in this case. The commission does not have jurisdiction to review the legal sufficiency of the commissioner's rulings. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23.

I HAVE SINCE BEEN TRYING TO GET JUDGE TO CORRECT. FIRST SHE SAID I WAS WRONG, THEN IN she corrected CASE AND I REQUESTED IN THAT MOTION TO CORRECT MY OTHER CASE ALSO BUT SHE did NOT. AND I NEVER got ANY NOTICE UNTIL A OUTSIDE SOURCE Told ME IN then AZ DOC WAS NEVER NOTIFIED UNTIL MONTHS AFTER SHE CORRECTED THAT CASE. THEN I FILED A NEW MOTION TO CORRECT ERROR ON CASE # DT BECAUSE JUDGE did NOT do it. THEN ANOTHER MOTION WAS FILED FOR ME ASKING FOR EXPEDITED RESPONSE. IVE BY ON ASK FOR A LAWYER, DUE TO INEFFECTIVE ALSO REPEATEDLY SINCE ASK FOR A LAWYER, DUE TO INEFFECTIVE COUNSEL, AS MY ATTORNEYS ON MY RULE 32 REFUSE TO GET THIS CORRECTED. SHE REFUSED ALL THAT, IVE ALSO Wrote CLERK COURTS, AND JUDGE TO BEGGING, PLEADING PLEASE CORRECT THIS ERROR. AND ALL I KNOW IS JUDGE JUST REFUSES, AND DIRECTED HER ASSISTANT OR STAFF ATTORNEY TO NOT RELEASE THE CORRECTED MINUTE ENTRY, OR HAVE AT AZ DOC CENTRAL OFFICE, TIME COMP BEEN NOTIFIED. SERIOUSLY I UNDERSTAND I AM A CONVICTED CRIMINAL, I HAVE NO MONEY FOR LAWYER, AND I AM NOT A LAW EXPERT WHO KNOWS HOW TO DO THIS, BUT I FEEL I AM NOT BEING TREATED FAIRLY.
