**ORDER**

The complainant alleged a justice of the peace has engaged in criminal conduct.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After review, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. The commission does not have jurisdiction to review the legal sufficiency of the judge's rulings. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23.

attached) That resulted in him awarding a \$1000 judgment to my Tenet( whom I had evicted for non-payment of rent)  
for the junk I had to haul of to the dump as the tenent had been imprisoned for making false statments and back  
warrents and wasn't even there- Which ment also her filing statment of case of me "destroying her  
furnature"( the basis of her case against me) was hearsay. Which judge carried for yrs. against me- not  
only ignoring the breifs I submitted that coincided the tenents suit to the day her male friend she was living with being  
found guilty of harressing me (in court) and yr. after the incedent. and the breif I submitted with the guilty  
verdict in superior court of her giving false statments to sheriffs deputies.(when she was evicted)  
I have all those briefs to show this commission that are evidence that the case was a reprizial by an  
evicted-then incarcerated tenent and boy friend to harress me using Judge court as a vehicle of their haterd  
which judge got so involved in these peoples lies he took the iniative against me by restricting my usage of the
