**ORDER**

The complainant alleges a superior court judge had a conflict of interest and should have disqualified herself in a civil case she presided over.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After review, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. The commission does not have jurisdiction to review the legal sufficiency of court rulings. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23.

Judge used parts of my Juvenile record to make her determination and sentence Mr. \_\_\_\_\_ to the Department of Corrections to a term of \_\_\_\_\_ on a class 4 felony. Even though my Juvenile record was supposed to be sealed and not used to determine my fate in this hearing. See attachment for verification. State of Arizona V. \_\_\_\_\_

In \_\_\_\_\_ I was charged with Aggravated Assault and unlawful flight. Where I was shot through the neck and beat with the butt end of a shotgun all by the County Sheriffs Department. I was later Acquitted of the charge of aggravated Assault and found guilty of the Unlawful Flight in \_\_\_\_\_. See State of Arizona V. \_\_\_\_\_; I.E. Trial Transcripts. I was sentenced to the Department of Corrections for Unlawful Flight.

A civil case was warranted and mandated by Mr. \_\_\_\_\_ and filed by Mr. \_\_\_\_\_. \_\_\_\_\_ after my criminal trial ended.
