ORDER

The complainant alleged that an administrative law judge with the Arizona Industrial Commission treated him unfairly.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

The commission does not have jurisdiction over administrative law judges in the executive department of state government. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23.
