ORDER

The complainant alleged two superior court judges were biased against him and made improper rulings in a family law case.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judges engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

The commission does not have jurisdiction to review the legal sufficiency of the judges' rulings. In addition, the commission found no evidence of ethical misconduct and concluded that the judges did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety as to both judges, pursuant to Rules 16(a) and 23.

I am writing this in regards to the blatant and harmful misconduct on the part of **Judge** related to case # Please reference evidence and audio transcripts from hearing

I want to start with asking some questions of the members who are reviewing this complaint. Please note that I am hopeful but not optimistic that this is not the case of the police evaluating the police. I challenge you to remove my belief that this system is broken all the way from the top to the bottom. A single individual should never be empowered to take from them without some committee or a higher authority to ensure that a bias isn't in place, as was the case here. Please watch the entire hearing and watch the judge's demeanor. Watch how clearly that Judge has no respect for me or concern for my life or I broke down in tears and the judge looked annoyed with me. This is my life. This is my life. This isn't a game. Because I sent emails letting my ex know that she is a controlling narcissist who is harming my and using as a weapon, I have been restricted from being part of my life. My communication with mother has nothing to do with me as a person, a professional and most importantly a FATHER. Therefore, the judge was biased in his ruling and this narrow and unreasonable criteria should not have been a foundation for ruling that I can't be a bigger part of my life. Not one shred of evidence indicated that father is not a caring and responsible parent, yet Judge ruled against me. That's an abuse of power and clear misconduct.

- Judge has judged me on the relationship I have asked this court to help sever?
- This divorce has rendered and yet Judge ruled against me for not getting mother in a timely manner and he completely disregarded that I had her that he could have ordered to be used as reimbursement as opposed to using that as an to rule against me. Then to add insult to injury, hold me accountable for her attorney fees. This is misconduct.

- Do you know what it's like to have someone use your [redacted] and the decree as a weapon and then be condemned by Judge [redacted] for non-threatening and non-physical means of expressing your discontent with mother?
- Do you know what it's like to have your first amendment rights handcuffed and then be judged and restricted from being a [redacted] to your [redacted] because the judge felt in spite of all of the harm mother is doing to [redacted] you have no right show discontent with that?
- Do you know what it's like to have lost everything you have every worked hard for just because you wanted to live separately from someone you could no longer live with. - Judge [redacted] has abused his power of [redacted] ruling and he has shown a blatant prejudice and bias in his harmful and unlawful rulings.

This document will explain in detail how Judge [redacted] AND Judge [redacted] have collectively ruled in a biased capacity and continue to perpetuate the reality that the [redacted] law system is broken and in many cases, it destroys lives. Our case has grown unnecessarily large because the system when being administered by people like Judge [redacted] and Judge [redacted] is abused.
