ORDER

The complainant alleged a justice of the peace improperly sentenced her in absentia, provided her with the wrong court date, and made inappropriate comments to her in court.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After review, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. The commission approved sending the judge an advisory letter advising him to thoroughly familiarize himself with the applicable rules of criminal procedure so as not to violate Rule 1.1 (Compliance with the Law), and to refrain from viewing social media postings that could lead to inadvertent ex parte communication and/or acquisition of factual information outside of the record so as not to violate Rule 2.9 (Ex Parte Communications). The complaint is dismissed pursuant to Rules 16(b) and 23(a).

Commission members Anna Mary Glaab and J. Tyrrell Taber did not participate in the consideration of this matter.
