**ORDER**

The complainant alleged a superior court judge was prejudiced against him and made improper rulings in a family law matter.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

The commission does not have jurisdiction to review the legal sufficiency of the judge's rulings. In addition, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23.

I am a 58 year old law abiding citizen of the United States that has had his constitutional rights denied. I was forced to go through a divorce even though I was never legally married. I was then ordered to pay spousal support. I got kicked out of my own home, and barred from seeing my children. I was forced to walk away from a company I started and ran for 27 years because of this judge with a vendetta.

I provided proof to the judge we where never married but he didn't care. This judge said: "that the marriage was a Matter and that we are here in Arizona for a divorce, and that's what we are going to have. A divorce." He ignored my rights, he ignored the law.

It was obvious this judge wasn't a judge he was just a man on a vendetta, so I left the country to avoid being arrested for non payment of something I didn't legally owe or have. I'm still ir I want my rights back.

This Judge ignored the laws, he made his own.

This Judge ignored the facts, he was bent on punishing me from day one.

This Judge ignored important issues of true value through the trial.

This Judge permitted perjury in court, right in front of him. He did nothing. No punishment, no warning, no restitution for admitted lies in court.

I checked this mans history and I am not the 1st to complain, he has a long history of this behavior. I want Justice. Please help me.
