**ORDER**

The complainant alleged that one appellate court judge improperly received an award and that another appellate court judge failed to report the misconduct of the appellate court judge who received the award.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judges engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

After review, the commission found no evidence of ethical misconduct and concluded that the judges did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety as to both judges, pursuant to Rules 16(a) and 23.

Dear Arizona Commission on Judicial Conduct,
