**ORDER**

The complainant alleged a justice of the peace was biased against her, denied her an opportunity to be heard, and made improper rulings in a civil matter.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

The commission does not have jurisdiction to review the legal sufficiency of the judge's rulings. In addition, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23(a).

The plaintiff filed their case on \_\_\_\_\_ in the wrong venue, I filed a motion for change of venue which was granted. I wasn't notified of this until \_\_\_\_\_ On \_\_\_\_\_ I filed my answer along with a counterclaim for violations under the fair debt collection practices act. On \_\_\_\_\_ plaintiff filed a application for default judgment against me, which I filed a response to. On \_\_\_\_\_ the plaintiff filed a motion to dismiss my counterclaim, On \_\_\_\_\_ the judge granted the plaintiff's motion to dismiss my counterclaim. I was not notified of this dismissal until it was mailed out on \_\_\_\_\_ This order was held back for \_\_\_\_\_ days before it was sent out. I filed a motion to reconsider the motion to dismiss my counterclaim on \_\_\_\_\_ which to this day has been ignored. I filed a rebuttal to plaintiff's affidavit for perjury, which has been ignored. I filed a notice change of judge on \_\_\_\_\_ which was ignored. I filed a amended answer on \_\_\_\_\_ On \_\_\_\_\_ plaintiff filed a motion for summary judgment. On \_\_\_\_\_ I filed another motion requesting a change of judge, which was granted on \_\_\_\_\_ because I felt that plaintiff was being given favor and my numerous motions and filings were being ignored. I filed a cross motion for summary judgment on \_\_\_\_\_ plaintiff filed a response to my motion change of judge. I found out that the change of judge was reversed when I went to ask about the status of my motions and they gave me a copy of the order. I was never given due process. There was never a hearing of any kind. There was never trial. The plaintiff failed to validate the alleged debt which I have been asking proof of since \_\_\_\_\_ and if the Judge had bothered to look at my filings, would have known there was a material fact dispute. The judge ignored all of my motions and all of my filings and all of my evidence. \_\_\_\_\_ denied me even the smallest measure of justice in this case. \_\_\_\_\_ refused to give me an opportunity to defend this action. \_\_\_\_\_ sided with the plaintiff in granting their attorney's motions and filings while ignoring mine. \_\_\_\_\_ seems to read and then quickly grant their motions, while ignoring and never considering any of my filings or motions. I believe that \_\_\_\_\_ rendered this judgment for the plaintiff because they were failing to bring this case to an end by stalling my efforts in obtaining relevant documents in this case and their time was quickly running out. I believe \_\_\_\_\_ has been extremely bias and has a severe conflict of interest. \_\_\_\_\_ did not follow the law when entering this judgment against me.

I am filing a motion to vacate a void judgment, but I am not expecting any justice \_\_\_\_\_ blatant disregard of the rules, disregard for the laws, and \_\_\_\_\_ obvious favor for the plaintiff is what led me to file this complaint against
