**ORDER**

The complainant alleged a justice of the peace was biased against her and improperly issued a protective order against her.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

The commission does not have jurisdiction to review the legal sufficiency of the judge's rulings. In addition, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23(a).

 recused herself from the case as she previously refused to grant a Temporary Injunction Against  
 Harassment to me back in \_\_\_\_\_ because the Defendant ( \_\_\_\_\_ )

 called \_\_\_\_\_ to tell him about the case. I ended up filing for the Injunction Against Harassment  
 in another less biased jurisdiction.

During the hearing on \_\_\_\_\_ was obviously biased toward the Plaintiff ( \_\_\_\_\_ )  
 and let him ramble on for quite some time while refusing to allow me to speak unless  
 asked a direct question. It was obvious she remembered who I was and if she didn't, the Plaintiff  
 mentioned the previous case during the hearing, even though it had no bearing on the current case.

There were no incidents of Domestic Violence between the Plaintiff and myself and most of the incidents  
 he brought up were incidents that didn't even pertain to our past relationship. He was claiming I was  
 harassing him via Social Media and email and I was not. The person who was is known as \_\_\_\_\_  
 and he has contacted me as well. The judge didn't ask the Plaintiff to prove his allegations and both he  
 and his witness, \_\_\_\_\_ both committed perjury under oath by lying to the Judge. I  
 mentioned this but, the Judge didn't seem to care.

\_\_\_\_\_ ruled to keep the Order of Protection in place against me, even though it was mostly  
 unfounded allegations and lies. She also ruled to invoke Brady against me. I don't own a firearm, nor  
 have I ever threatened the Plaintiff. I believe she did this out of spite. She also refused to answer my  
 question about whether I needed my own Order of Protection against the Plaintiff. Very rude and  
 unprofessional in my view. I have since obtained an Order of Protection against \_\_\_\_\_ out of  
 \_\_\_\_\_ so as not to have to deal with \_\_\_\_\_ and her bias against me.
