**ORDER**

The complainant alleged a municipal court judge improperly found her guilty of speeding.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

The commission does not have jurisdiction to review the legal sufficiency of the judge's rulings. In addition, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23(a).

I explained to the judge that we seen numerous police after making a right turn on red to proceed into the left lane. I also explained to him that we were all speaking a bout the police being everywhere and then a motorcycle cop on the opposite side looked into my car and immediately made a u turn and pulled us over. I informed the judge at the hearing that I felt the cop looked over at us and bust a you turn because he was judging. That cop who name is \_\_\_\_\_ immediately asked my son \_\_\_\_\_ (non driver) for his ID. My son being of color and I am white is the reason why we looked suspicious to the cop. I informed \_\_\_\_\_ on several visits at the \_\_\_\_\_ about how it was not fair that the cop said my son looked like a suspected murder and then back up came. At the trail the judge asked \_\_\_\_\_ why he needed back up. The cop stated that it was because he was using a motorcycle. I have seen motorcycle cops on the side of the road ALONE with no back up successfully stopping other drivers. I asked \_\_\_\_\_ did he clock me. He said no, it appeared I was driving fast so he then turned around and then clocked me. This is not true. I tried to tell the judge I would give him map quest directions and to pull up on that day all of the police who had stopped vehicles within our visual site. I explained why would we speed seeing police everywhere after making a right turn. \_\_\_\_\_ at one occasion when I requested a walk-in got up from his bench and said he was done with me. He will not listen to me anymore and that I pay or my cars will keep getting taken. I was only trying to do what is fair and that is not pay for something I did not do. My son was the reason why I got a ticket. It was to justify his stop. On \_\_\_\_\_ I revisited the courthouse to ask for a walk-in because I wanted it recorded to request a select seat hearing. The judge performed his hearings in the lobby. I feel it was because the receptionist already knows me from visiting so many times telling my story that he did not want it recorded that I was trying to file a complaint on the judge. \_\_\_\_\_ on \_\_\_\_\_ in front of my 18 year old daughter who was also a back seat passenger on \_\_\_\_\_ (initial incident) witnessed everything the judge said to me. \_\_\_\_\_ I said he dismissed my appeal and that it doesn't matter if it was a profile stop or not, he has made his decision and no one can do anything about it. Either pay or never get a license. He also said again I'm done with her escort her out. I have made payments on this case. Only because it would temporarily reinstate my license. I am a \_\_\_\_\_ and it is required I have a valid driving license to get booked for any events I do for \_\_\_\_\_, etc. My agencies have ran back ground checks and I look like the bad person. This is not fair. \_\_\_\_\_ seen I filed an appeal. They don't know what happened to my statement that I wrote and I spent 8 total days in jail over this and spent up to 7,000 dollars on cars, insurance, rent a cars, paying for places to sleep in \_\_\_\_\_ to go to work because \_\_\_\_\_ has no public transportation. I lost gigs over this. My picture was on the Internet and I had to write to \_\_\_\_\_ and a bail bond agency that I never even used to remove my photo because it is slander and false info ion the Internet about me. I am not a criminal. I did not speed that day. The cop look over at us and did a you turn and then immediately requested the non driver(my son) identifucation. \_\_\_\_\_ did not believe me and wont give me back my license and got up walked off the bench without ajuring court. Thats childish behavior because he knows he is wrong.
