ORDER

The complainant alleged a superior court judge allowed his daughter to be abused.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the judge engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

The commission does not have jurisdiction to review the legal sufficiency of the judge's rulings. In addition, the commission found no evidence of ethical misconduct and concluded that the judge did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23(a).

them. They have no medical evidence that the drugs are required. They also have no medical test proving she has a condition. This judge also admitted in court

he would have a psychological test if he was asked to. I am asking him to be tested. I feel he is not fit to be a judge and I question how many kids have been

hurt from his support of child abuse and child assault. I have no trust in him. I

understand he has no medical background to deal with my daughters health and

relies on false reports on people that are making a profit. I understand his knowlege is only on taxes. My daughter has also been sexually molested from boys

they put her with. Also she is in danger by being left alone with people that yell at her. He continues to accept the false reports blaming all this harm on me the

father. I have to buy her clothes and shoes because they dont have money to take care of my

daughter. They also made her eat with her hands for months like an animal. My daughter cried and asked the judge

to let her be home with her brothers and parents but the judge said no for no reason. They also did not allow my daughter to have a toothbrush to clean her teeth

for months and allowed her to get cavities while they fed her a processed sugar diet. They falsely blamed my daughter on self harm when ever they harmed her

and she was just wanting to escape. I have all the records and written proof of everything I have written and will provide it if asked. My daughter also was

forced to walk with bare feet for months and not allowed to wear socks or shoes. My daughter has suffered for no reason. Also a nicotine patch was put on my

daughter for no reason she never had a cigarette or drugs in her life before. From,
