**ORDER**

The complainant alleged a superior court commissioner was biased against her, improperly dismissed an order of protection, and rolled his eyes at her.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the commissioner engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

The commission does not have jurisdiction to review the legal sufficiency of the commissioner's rulings. In addition, the commission found no evidence of ethical misconduct and concluded that the commissioner did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23(a).

I have requested an Order Prohibiting Harassment / Order of Protection against my ex-husband who is on several occasions. He has slandered me on social media, harassed me, stalked me, falsely accused me in court under oath which I have documented proof of his perjury and he has been allowed to continue to do so because of Commissioner \_\_\_\_\_ and Judge \_\_\_\_\_. They totally disregarded the proof that I provided of him blatantly committing perjury in their court and instead granted an order against me for notifying \_\_\_\_\_ of his actions and perjury.
