ORDER

The complainant alleged two commissioners were biased and treated her unfairly.

The responsibility of the Commission on Judicial Conduct is to impartially determine if a judicial officer engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

The commission does not have jurisdiction to review the legal sufficiency of a judicial officer's rulings. In addition, the commission found no evidence of ethical misconduct and concluded that the judicial officers did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23(a).

I have filed complaints against [redacted] and [redacted]. It seems it doesn't stop for anybody affiliated with them is doing Judicial Misconduct.

When [redacted] orders on me and I contested [redacted] of them he [redacted] himself. The [redacted] he [redacted] himself were issued to [redacted]. These two are my main concern in this complaint because I had the other one dismissed by an unbiased and fair judge. However when he issued [redacted] they listed each other as other protected persons. That would basically mean I would have [redacted] orders on me. [redacted] was sloppy in allowing [redacted] to be issued and [redacted] of them wasn't even signed by him, but the

When I contested [redacted] he recused and sent me all the way to a [redacted] with Judge [redacted]. This was very odd for [redacted] and the orders were issued [redacted]. The [redacted] I believe he sent me to [redacted] to [redacted] because he knew her and told her of the situation. This would make it an unfair and biased judge. The order just changed from one biased judge's hands to another. I knew as soon as I walked in the courtroom I was not going to get a fair hearing for Judge [redacted] mannerisms plainly displayed this.

I had a [redacted] with me and already the [redacted] were bogus for the dates and events were false. This judge allowed them to show video's not pertaining to anything that was on the [redacted]. I told [redacted] these orders were simply being used by them so they could get me to violate them and send me to jail. How do I know this? Because they have harassed me so bad it brought me to my breaking point and I did go to [redacted]. They put up [redacted] and watched me as I came and went from my condo. The harassment they have endured on my life and mental status has been too great for one human being to bear. They [redacted] among other things. I have had a valid [redacted] on these individuals for [redacted] now. The last [redacted] order I got on them was from [redacted] listened to the witnesses I had and looked at all the overwhelming evidence of harassment I claimed against them. [redacted] stated, "[redacted]". That is in the record.

I know judge [redacted] did not give me a fair hearing and [redacted] even allowed them to each have their orders listing each other as other protected persons. The state of Arizona is responsible for this misconduct and I want it to stop. There should be no more of these orders issued at [redacted] where my next door neighbor and [redacted]. This is a major Conflict of Interest. [redacted] is abusing her authority and nothing is being done about it. If they want to claim I am harassing them then go right ahead. I am merely stating there should be an unbiased judge to look at their claims. No more of these orders should be issued at [redacted] or any of [redacted] colleagues. Justice is supposed to be blind but I have lost all faith in the system. The claims [redacted] have constantly and falsely claim are absolutely destructive and they are perverting justice to fit their unethical behavior.

I want [redacted] to be investigated for I already have the evidence she never should have allowed [redacted] listing each other as protected persons. You only get [redacted] and list the other or get [redacted] each leaving the other person out. I also know this judge allowed them to rant on about nothing having to do with the petitions they filled out. In fact he assaulted me and their claims of harassment were all fabricated. It is also suspicious as to why I had to go all the way to [redacted] to contest these orders. It is odd I would have to go out of the [redacted] area when [redacted] and the orders were filled out at [redacted]. All this is very suspicious and I want justice. If this state doesn't do something about it then I will go to a higher authority. I will have these matters looked into one way or another.

This needs to STOP immediately for I have had a mental breakdown and the responsible parties are the State of Arizona.

I filed Judicial Misconduct on commissioner [redacted] for him and he issued [redacted] when he never should have. These [redacted] these [redacted] get on me are used to harass me and any judge affiliated with [redacted] should not be trying my cases. I am not getting a fair and unbiased hearing with any of these judges.

On [redacted] [redacted] The dates on the petition as to my harassing these [redacted] were totally fabricated. I have not had any contact with them for [redacted]. When I contested this petition on [redacted] I knew I was not going to get a fair hearing due to this judge being [redacted] and [redacted]

[redacted] I walked in to the court with my [redacted] and all my evidence. The evidence I had and the overwhelming proof I had with my [redacted] showed I made absolutely NO contact with these [redacted] whatsoever.

As I was instructed to go in the courtroom judge [redacted] was already conversing with and their [redacted]. The judge gave his instructions and what seemed to be a very cut and dry case turned out to be a one sided deal. [redacted] and the judge did not allow my [redacted] to talk. They were sworn in in the beginning but he did not allow my evidence to be presented before the court whatsoever. The lawyer was bringing up events that had taken place over [redacted]. I kept objecting to this but the judge allowed it to be presented before the court. This behavior the [redacted] is unacceptable for I am not getting a fair trial but biased judges.

I want it to also be noted that I have had [redacted] on [redacted] in the past and at the time of this trial [redacted]. My injunctions on them were enforced by judge [redacted] at [redacted]

The harassment I have endured from all these individuals is recorded in the [redacted]. In fact it was so bad Judge [redacted] stated, " [redacted]

I informed judge [redacted] that new bogus [redacted] have been issued on [redacted] and she told me to have [redacted] call [redacted] personally to inform [redacted] of the harassment I am enduring. At the hearing [redacted] said he would not call her and it will be his ruling. This judge was not letting me present my case in a fair manner whatsoever.

I am disgusted with the judicial system for not being fair and I plan on taking action against the [redacted]

Do not allow any more bogus [redacted] on me for it is obvious they are using them to harass me.

Anybody affiliated with [redacted] There should not be any more issued [redacted] They are misusing their status

and their power to persecute me and the State is responsible.

I would appreciate it if you would thoroughly look in to this matter for it has gone on way too long. My [redacted] in the [redacted] have greatly declined due to [redacted] of the harassment.

This needs to stop NOW. I own my home and [redacted]. They have [redacted] watching me as I come and go from [redacted]. When they see me they constantly come out to torture me so as to get me to react to their torture and capture [redacted] so they can use this false evidence saying I violated a [redacted]. They have done it in the past and are still doing it.

This type of behavior is unacceptable from them, but especially from judges that obviously have a Conflict of Interest along with any [redacted]

Please put a stop to this at once.
