**ORDER**

The complainant alleged a justice of the peace improperly evicted her and improperly denied her appeal as untimely. The complainant also raised allegations of misconduct against various court employees over whom the commission lacks jurisdiction.

The responsibility of the Commission on Judicial Conduct is to impartially determine if a judicial officer engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

The commission does not have jurisdiction to review the legal sufficiency of a judicial officer's rulings. In addition, the commission found no evidence of ethical misconduct and concluded that the judicial officer did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23(a).

Commission member Art Hinshaw did not participate in the consideration of this matter.

My name is [redacted] and I want to file a complaint on The [redacted] court office of administration in [redacted]

I have had several discriminative encounters. This is a repeated pattern with this office and I feel it is my duty to go above their title to report these incidents.

Recently on [redacted] I arrived at [redacted] to pay [redacted] on my ticket under my name [redacted] I was on a monthly payment arrangement.

If you look in the system you will see that on the same date we paid my [redacted] overdue ticket in full at the clerks office down the street via [redacted] card.

I tried to pay [redacted] using my [redacted] card (just had direct deposit from job who paid us over [redacted] days later) (have proof), fortunately the computer screen beside my account and NAME had this [redacted] under the amount owed. It would not allow me to click on it and pay.

The front desk associate advised me that the reason why I could not pay was because it was "late" but she could accept cash or cashier's check.

Well [redacted] is over [redacted] drive time to the closet [redacted] (fact check) and I had no cash in hand.

I asked her if we could come back after I went to [redacted] also over [redacted] away) (only place to buy affordable groceries) ([redacted] is NOTHING land and hinders poor people from affordability) she said yes.

My [redacted] got a flat again and I had to wait on [redacted] for a ride which this process took over [redacted] hours and I had to go to Buy a part to purchase the oil dip stick casing because oil was leaking out excessively due to the previous street mechanic whom did not place this part back on when replacing my starter. (have proof of purchase with date)

I went back in the court house with my proof, explained that now I spent that money n need to speak to the judge. She asked if I could give her [redacted] that it NOT been sent over to [redacted] that would be suffice.

I ran out to my [redacted] grabbed the purse came back in to pay and then she says " Oh, sorry she just sent it over"

Ok. I dont have time for these games about these woman in this office whom on previous occations:

1. When I went in to file "an answer" to a bogus judgement from one of these rent to own scam dealerships named [redacted] which I signed a non disclosures to only deal with their arbitrators, and they rented me a car that on the [redacted] I got pulled over for [redacted] and the windows did not roll down ( safety violation, I have [redacted] its over [redacted] n can die because rhe AC was blowing out very weak n needed repair also), the [redacted] informed me at court that he had years of safety experience and this was a violation. Upon that stop I was arrested [redacted]

He asked for my whom was not the driver, said he looked like a murder that fit a description, my is black and lived on campus at of and was only here visiting. They had additional police come and when we were "cleared" he justified his stop by saying we were speeding" (I filed a complaint also with the court house and panel of judges) so as you can see I was not speeding and had the right to refuse to pay a ticket that I did not violate that day we were profiled stopped. In for these the intake officer at said he would " me with paddles while I undressed then placed me in not the security.) All a ticket that I did not do. This court house same workers denied me the right to file my answer free with a yearly reported to income of only

2. They evicted me paying rent at .

If you look in my file you will see I had All my rent paid up when the new lawyer filed to evict me because my landlord who lived out of state was getting ripped off by the who came and took my rent. Thats not my issue. I paid. She stole money and he fired her and hired this new company who filed for failure to pay even after I emailed them my receipts also( emails never go away. I still have them) This same said on the date of my hearing that my could go in for me because I had work and could not miss anymore days. She was added on my lease ,the clerk had me drive home get the lease where she was added on which is in the case file also. The judge still evicted me. Denied my appeal. I spent days in tbe in until I could move in to a house in I filed an appeal on the calendar day only beavuse of the holiday and the weekend. Look at the dates. This was wrong. It hindered my life. Wasted money and we all contracted have test results and mine went to have that proof as weel which led to the terminatio of my job n of unemployment missing too many days.Sad. We spread this only because of us were in a room i If we were not wrongfully evicted we would have not all been infected because it was a bedroom house and we could have quarantined my when he was first exposed.

So, You can see my frustrations and my opinion that for some reason this office keeps using their authority to finanicaly distroy me and my reputation.

I have been too open with my life with these woman and feel they for some reason think I have more money than I have and dont allow me my rights to a fair justice. The judge also under the mic said that it is a privilege that I pay with a card (it was a card from a direct deposit). I should be allowed to pay any way I want as long as Im paying. For him to refuse my

payment and try and justify his clerks actions were not justice and In my opinion a violation of my rights.

The system on [redacted] should allowed me to pay debit. I went back in there after all this happened and looked up my account and wouldnt you know it showed the total amount and allowed me to click on pay and the box was blinking to add in any amount.

They were just to lazy to walk out behind the glass and fix it and then the judge lied under oath about why it would not accept my payment that day.

My payment should have bern accepted on that day and none of the following would have ovured causing yet again my [redacted] to [redacted] and me not be able to work and afford enough food n living expenses.

This is wrong. All [redacted] of these incidents were wrong. They could have been handeled better which only distroyed my life not theirs.

I want justice.

I deserve justice.

I should have not been evicted. Now its on my credit and I cant rent.

I should have been allowed to file my answer to that bogus judgement because my [redacted] was below the bracket for a [redacted] of [redacted].

i should have been able to make my payment on [redacted] in the amount of [redacted] using their computer if the lazy staff team just used common sense and entered [redacted] before my case number which i was later informed about by another person.

Look up this fact. [redacted] before case number. That was their job responsibility to assist us. I dont work there they do.
