ORDER

The complainant alleged a superior court commissioner engaged in improper demeanor, gave legal advice to the opposing party, and made improper rulings in a family law matter.

The responsibility of the Commission on Judicial Conduct is to impartially determine if the commissioner engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the Commission is limited to this mission.

After review, the Commission found the commissioner was not “patient, dignified, and courteous.” While this was improper under Rule 2.8(B), the Scope Section of the Code of Judicial Conduct provides that it is not intended that every transgression will result in the imposition of discipline. The Commission decided, after considering all the facts and circumstances, to dismiss the complaint pursuant to Rules 16(b) and 23(a), but to issue a warning letter to the commissioner reminding him of his obligations under Rule 2.8(B).

Commission members Denise K. Aguilar, Louis Frank Dominguez and George H. Foster, Jr., did not participate in the consideration of this matter.
